SUBJECT: Revocable Encroachment Permit - 20th Street Ventures

SUMMARY

20th Street Ventures has applied for a revocable encroachment permit for the purpose of replacing existing sidewalk with exposed aggregate sidewalk. The City Engineer recommends that the permit be granted.

BACKGROUND

The area for which this request is being made consists of an area adjacent to Permittee's property, 16-1/2' x 80-1/2' along the east side of 20th Street, between 0' and 80-1/2' north of the I-J Alley at 911 and 915 20th Street (westerly portion of County Assessor's Parcel Nos 7-016-1 and 2).

RECOMMENDATION

The City Engineer recommends that the attached resolution be passed granting a revocable encroachment permit to 20th Street Ventures in the area and for the purpose outlined above.

RESOLUTION GRANTING REVOCABLE ENCROACHMENT TO:

20TH STREET VENTURES

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That a revocable encroachment permit for the purpose of replacing existing sidewalk with exposed aggregate sidewalk

is hereby granted to 20th Street Ventures, whose address is as follows: 1717 I Street, Sacramento, CA 95814.

The encroachment area is described as follows:

An area adjacent to Permittee's property, 16-1/2' x 80-1/2' along the east side of 20th Street, between 0' and 80-1/2' north of the I-J Alley at 911 and 915 20th Street (westerly portion of County Assessor's Parcel Nos 7-016-1 and 2).

This permit is granted subject to the "General Provisions - Revocable Encroachment Permit", which were adopted by the City Council in Resolution No. 77-611 dated October 4, 1977, and the hereinafter specified special conditions, if any. This permit shall be effective only after the applicant files with the Department of Finance of the City of Sacramento, the insurance certificates required by the General Provisions.

SPECIAL CONDITIONS

1. The Permittee shall comply with all the requirements of the City Planning Dept. and the Building Inspections Division.
2. Permittee shall conform with requirements of Street Maintenance Division. Before placing exposed aggregate sidewalk, notify Bill Seeber at 449-5236.
3. Permittee shall maintain all exposed aggregate sidewalk pertaining to this permit.
