BACKGROUND INFORMATION

As a consideration of approval of the tentative subdivision map for Lakecrest Village Unit No. 2A, a private contract was required for the construction of the subdivision improvements. The owner of the property has executed a contract with Teichert Construction for the construction of said improvements.

The construction of Greenhaven Drive is a major arterial and calls for City participation in it's construction. The City's share for constructing Greenhaven Drive, based on the bid prices, is \$31,612.22.

FINANCIAL DATA

Funds for the City's portion (\$31,612.22) will be paid out of the City Engineers Budget No. 2-09-2600-1017-4820 when the funds become available and according to where this particular project appears on the priority list established by the City Engineer.
