Recommendation: Adopt a **Resolution:** 1) approving plans and specifications; 2) awarding the construction contract to Granite Construction Company for an amount not to exceed \$1,443,438; and 3) authorizing the City Manager to execute the contract.

Description/Analysis

Issue: Bids have been received for the 2009 City Street Overlay Project. Granite Construction Company is the lowest responsive and responsible bidder. City Council approval is necessary to move forward with awarding the construction contract.

Policy Considerations: This action requested herein is consistent with the Sacramento City Code, Title 3 and with the City of Sacramento Strategic Plan goals of sustainability and improving and expanding public safety. Approximately 23,000 recycled tires are to be used as part of this project.


Environmental Considerations: The Development Services Department, Environmental Planning Services Division has reviewed the proposed action and determined that the project is exempt from the provisions of the California Environmental Quality Act (CEQA) under Class 1, Section 15301(c) of the CEQA Guidelines. Class 1, Section 15301(c) consists of the maintenance, repair or minor alteration of existing highways, streets, sidewalks, curbs, gutters and similar facilities including road grading for the purpose of public safety.


Rationale for Recommendation: Granite Construction Company is the lowest responsive and responsible bidder. Project funding is sufficient to award the contract.

Financial Considerations: The 2009 City Street Overlay Project (R15072014) has a current budget of \$203,481 consisting of local transportation funds. There are no general funds planned or allocated for this project. The approval of the fund transfer in the amount of \$1,741,450 from the FY09 Street Overlay and Seals Program (R15072000) will increase the total project budget to \$1,944,931 with an unobligated balance of \$1,675,381. This balance will be sufficient to execute the contract for an amount not to exceed \$1,443,438 with Granite Construction Company and cover staff costs for the remaining construction management costs.

The approval of this project will support 41 jobs in the City of Sacramento based upon the model provided by the Federal Highway Administration (FHWA) of one new job for every \$35,000 of transportation project investment.

Emerging Small Business Development (ESBD): The ESBD goal is 20%. To encourage small and emerging business participation, plans and specifications were sent to 19 plan rooms and construction service organizations for publication. All are directly involved with Emerging and Small Business Enterprise (ESBE) construction firms. The project was also announced on the City's Project Internet site at www.cityofsacramento.org/bids. Granite Construction Company has achieved 22.3% ESBE participation.

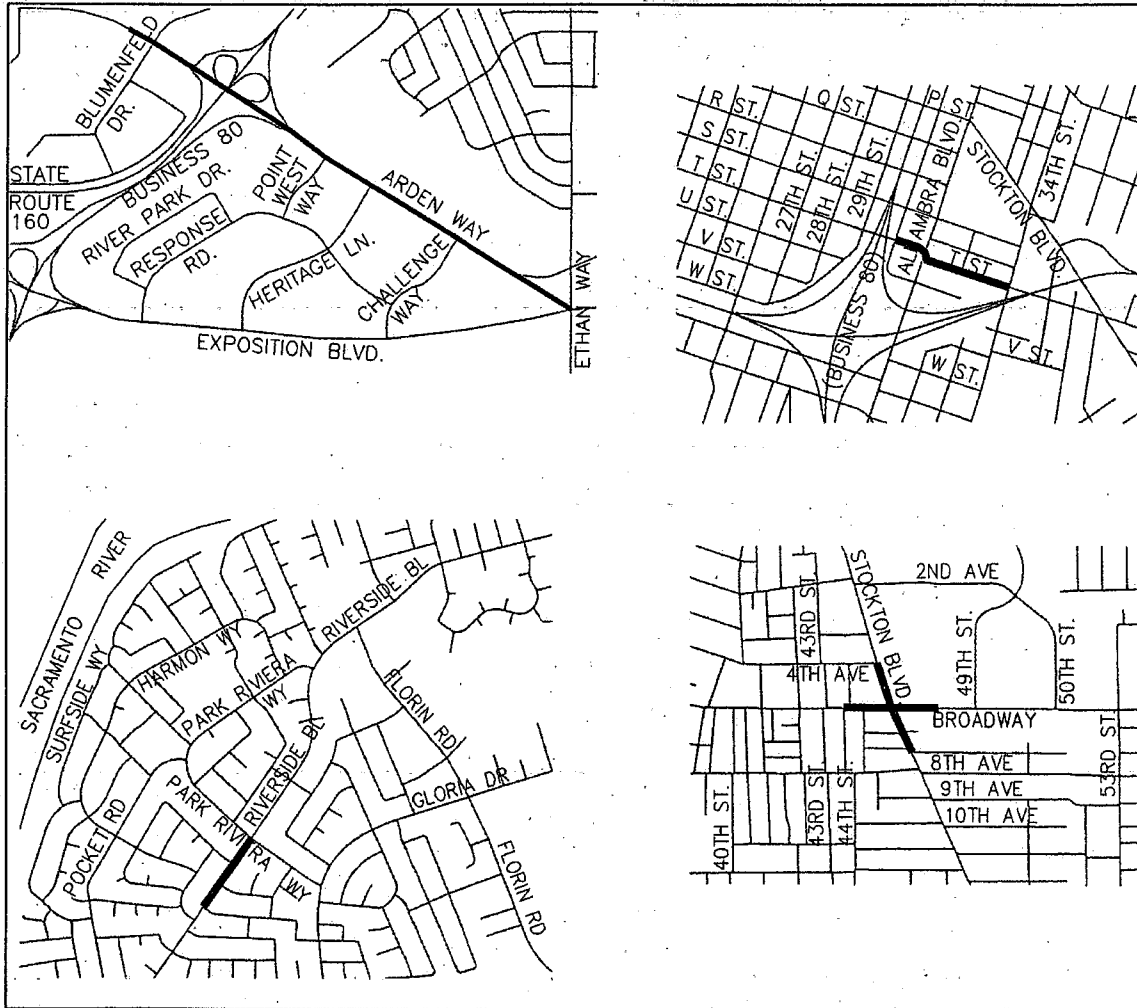
