"AN ORDINANCE AMENDING ORDINANCE NO. 259, FOURTH SERIES, PASSED DECEMBER 24th, 1925, AND ENTITLED": AN ORDINANCE ESTABLISHING A CITY POUND, CREATING THE OFFICE OF POUNDKEEPER AND PROVIDING FOR ASSISTANTS TO THE POUNDKEEPER, FIXING COMPENSATION, FIXING THE AMOUNT OF BOND TO BE FILED BY POUNDKEEPER; REGULATING THE KEEPING OF ANY HORSE, MULE, ASS, KINE, HOG, SHEEP OR GOAT; REGULATING THE KEEPING OF DOGS AND PROVIDING FOR THEIR REGISTRATION; MAKING IT UNLAWFUL FOR DOGS TO RUN AT LARGE; PROVIDING FOR THE IMPOUNDING OF ANIMALS RUNNING AT LARGE AND THE MANNER IN WHICH SUCH ANIMALS MAY BE REDEEMED OR DISPOSED OF; REGULATING THE KEEPING OF DOGS SUSPECTED OF BEING AFFECTED WITH RABIES; MAKING IT UNLAWFUL FOR ANY PERSON TO HARBOR OR CONCEAL A DOG RUNNING AT LARGE; FIXING THE PENALTY FOR THE VIOLATION OF PROVISIONS OF THIS ORDINANCE, AND REPEALING ORDINANCE NO. 257, THIRD SERIES, ORDINANCE NO. 289, THIRD SERIES, ORDINANCE NO. 63, FOURTH SERIES, ORDINANCE NO. 116, FOURTH SERIES, AND ORDINANCE NO. 129, FOURTH SERIES," BY ADDING A NEW SECTION THERETO TO BE NUMBERED SECTION 13 $\frac{1}{2}$ ".

Seconded by Councilman John H. Miller and carried as follows:

In accordance with petition and recommendation of City Manager which were ordered filed, Councilman John H. Miller moved that refund of \$500.00 on Restaurant License of L. Engasser at premises No. 1731 E Street be granted. Seconded by Councilman Conley and carried as follows:-

AYES: Councilmen Bellhouse, Conley, Goddard, Kiernan, John H. Miller, Royal Miller. ABSENT: Councilmen Anderson, Bidwell, Elliott.

Petition of property owners requesting installation of arc light at intersection of 10th Avenue and 53rd streets was presented by Councilman Goddard and referred to City Manager for action.

Councilman Goddard introduced the following Resolution:-

RESOLUTION NO. 131, CITY COUNCIL.

IN HONOR OF THE VALOROUS SERVICES OF SERGEANTS VAN MATRE AND RONEY OF THE SAN FRANCISCO POLICE DEPARTMENT.

"WHEREAS, Sacramento was unfortunately one of the Cities infested with the ruthless, lawless and murderous perpetrations of one of the State's most defiant desperadoes - "Tanko", and

"WHEREAS, this City has been deeply concerned in the capture and award of justice to this and his allied fugitive from incarceration, because of the atrocious murder of one of Sacramento's worthy citizens and merchants, namely, Harry J. Litzberg, the personal friend and classmate of the Mayor and other members of the Sacramento City Council, and

"WHEREAS, Patrolman Clyde E. Nunn of the Police Department was also the victim of a wound inflicted by the foregoing convict in a returned reign of "terror" banditry in this City, and

"WHEREAS, after many months' search over the State and Country, through ingenious detection by members of the San Francisco Police Department the long-sought law-breaker was successfully traced, fearlessly encountered, and his notorious activities forever terminated by Sergeants Vernon Van Matre and Earl Roney who barely escaped fatality,

"NOW THEREFORE, BE IT RESOLVED, that the City Council of the City of Sacramento, gratified with the cessation of this extended series of abhorrent outrages, recognizes and highly commends the unusual valor and courage displayed by Sergeants Van Matre and Roney, and on behalf of the City extends the thanks of our people to these Detectives for their meritorious services, and

"BE IT FURTHER RESOLVED, that the City of Sacramento hereby tenders its congratulation to Mayor Rolph and the Board of Supervisors of the City of San Francisco upon the employment of such efficient officers, through which Board the City Clerk is hereby directed to transmit a copy hereof to Sergeants Van Matre and Roney with best wishes for their speedy convalescence. "

Councilman Goddard moved that foregoing Resolution be adopted. Seconded by Councilman Kiernan and carried by following vote:

AYES: Councilmen Bellhouse, Conley, Goddard, Kiernan, John H. Miller, Royal Miller. ABSENT: Councilmen Anderson, Bidwell, Elliott.
