Notice Title: Implementation of Credit Card Service Fee  
Location (of project): Citywide

**Project Description:** Consider the adoption of a Resolution approving the proposed credit card service fee for payments made to the City using credit cards. As approved in the FY2024/25 Approved Budget, the new citywide process to charge the proposed fee was developed due to the funding reduction of City subsidies for credit card service fees. Costs would be passed onto the users.

**Environmental Determination:** Approval of fees and the maintenance of a website does not constitute a "project" and is therefore exempt from CEQA according to Section 15601(b)(3) of the CEQA guidelines.

**Prior Commission/Committee/Director Action:** City Council approved the FY2024/25 Approved Budget on June 11, 2024 (Resolution No. 2024-0193).
