CALL TO ORDER and ROLL CALL

Meeting called to order at the new Animal Shelter Cattery, 2127 Front Street – Multipurpose Room, Sacramento, California, at 6:10 p.m. by chairperson, Pat Wilcox.

CONSENT CALENDAR

1. **REVIEW AND APPROVE MINUTES OF 10/28/2008**

Motion to approve the minutes of 10/28/08 was made by Lety, seconded by Marge. MSP by unanimous vote.

2. STAFF UPDATE ON PROGRESS OF DONATION TREE AND RADIO **ADVERTISEMENTS**

Updated information regarding the cattery's donation tree and the radio advertisements for the Shelter was provided. Rhino Designs, the vendor who designed, produced and installed the objet d'art in the cat colony rooms, is designing and manufacturing the donation tree. The design of the tree is a continuum of the Cattery's interior design, is produced by a local vendor and the cost is less than originally budgeted. The promotional advertisements offered by CBS

radio promoting a package that will provide radio time on 6 local stations and 100 streaming commercials for a cost of \$1,000 per month was discussed. The usual rate is \$1,000 per station per month. Shelter staff will work with General Services Department Media Rep, Rhea Serran, to produce the content of these ads for the month of February 2009. Report received and filed.

3. INFORMATIONAL REPORT ON SHELTER SIGNAGE

Bev and Marge reported on the status of the project to add signage, referencing the City Shelter, in various strategic areas around the City. Both Bev and Marge are reviewing a variety of pictures, themes, and materials that will attract the interest of the public and offer an inviting view that will bring more people to the Shelter. They will research the cost, City street (signs and markings) codes regarding "right-of-way" that will be discussed at a future meeting. STAFF REPORTS

- 4. Manager's Report Update on Facilities and Shelter Events
 Reina Schwartz, Interim Animal Care Division Manager, addressed the following:
 - 1) Recruitment for a permanent replacement in Hector's position, the Animal Care Division Manger, will proceed in the Spring of 2009. Reina indicated various venues will be pursued in advertising the position, including recruitment at the CACDA conference. Estimates are the recruitment period will take 2 4 months to finalize. Reina will be the main point of contact for information and recruitment and will remain interim Animal Care Division manager during this period.
 - 2) Regarding the Supervising (Chief) Animal Care Officer, Reina is waiting for information and answers from the City Manager's Office before she is able to provide any information regarding this position. Her office phone number was provided to the Committee: 808-7195
 - 3) Budget Information: Vacancies will be used to off-set reductions in funding in order to balance the budget.
 - 4) Reina eventually would like to divide the Shelter and Field operations into separate units, with separate managers.
 - 5) Shelter/Field Operations Update: Danny reported the following:
 - a. Training: One (1)1 ACO was sent to "Illegal Animal Fighting and Animal Investigations". Three (3) ACOs were sent to CLETS training for police reporting to run DMV registration checks through the Police Department database. An additional 3 ACOs are scheduled for this training.
 - b. Ricardo is the newest ACO and remains off duty until approximately 12/10/08.
 - c. The Shelter has been authorized to fill one (1) ACO position.
 - d. The case of the pit bull puppy that was kicked so viciously that it had to be euthanized was filed as a felony cruelty case.
 - e. Dia asked: of the 349 animal cruelty calls the ACOs responded to in calendar year 2008 (as previously mentioned by Danny) what is the percentage compared with all calls the ACOs responded to? Danny responded that there is no system in place to determine the outcome of the cases, only the outcome of the animal.

The outcomes of the animals in these cases were: 74 animals impounded, 26-29 were DOA (dead on arrival), 10 were adopted, 25 were euthanized at the Shelter, 2 were euthanized at a vet clinic, 3 were Returned to Owners, 3 were transferred to other facilities.

- f. Danny indicated he has initiated a new process for submitting cases to the DA that will provide more accountability: the ACOs are now required to submit a cover sheet to the DA for better tracking of the cases and the outcomes.
- 6) Reina spoke about the ASPCAs "Mission Orange" program. The Shelter, together with the SSPCA, the County AC&R and Happy Tails, is again submitting an application for this grant.
- 7) The Shelter will be upgrading the Chameleon database to the newest version, which will allow better tracking of field activities and streamline many processes currently completed through time-consuming manual procedures. The new version should also allow better tracking of cruelty cases & outcomes.
- 8) Dia asked about the City's policy regarding trapping animals, and if the Shelter allows unattended traps to be set? Reina replied, yes, and she will assign staff to provide answers regarding the policy.
- 9) Additional questions posed by Dia:
 - a. Of the 349 animal cruelty calls, how many cases were actually sent to the DA? Danny responded that it is difficult to track under the current system, but provided a rough estimate that of perhaps 50 sent to the DA, maybe 30 cases were prosecuted.
 - b. Of the 26-29 DOAs, in what area and in what circumstances were they found, i.e., were they beaten? Found in the road?
 - c. When will Hector's job be filled? Reina stated she expected to compete the hiring sometime in Fall 2009; until the position is filled, Reina will act as the interim division manager.
 - d. What about the Chief's position and the recruitment process? Will the position be posted? Reina replied that, since it is an exempt management position, the hiring process and the position is not subject to Civil Service rules; the City is not required by law to open the position. Danny, as a retired annuitant, is subject to City rules that govern working hours; City rules limit these to 960 hours per year.
 - e. Will the Chief's position be opened for recruitment? Reina can not answer at this time
- 10) The dog agility area will require additional input from the City's procurement division and FOCAS funds have been approved for this project. Additionally, Reina will keep the surgical building in mind when the budget situation improves.

5. SHELTER REPORT - F.O.C.A.S. FUND

Donna Wicky distributed the revenue/expenditure reports for the FOCAS fund. Report received and filed.

6. PUBLIC COMMENTS - MATTERS NOT ON THE AGENDA

Dia stated that she was asked by a number of rescue groups and volunteers to thank Donna for her work at the Shelter and for providing accurate statistical reports to the committee, animal coalitions and various animal volunteer groups.

The letter regarding the off-site adoption center will be re-addressed to the new mayor, Kevin Johnson.
