**SUBJECT:** Authorization to Amend the City Budget for FY 1985-86 - Summer Youth Employment

### SUMMARY

This report recommends amending the FY 1985-86 City budget to reflect funding to be received from the Sacramento Employment and Training Agency for a Summer Youth Employment Program in the amount of \$71,810. This report further recommends authorization for the City Manager to serve as official City representative for the 1986 Summer Youth Employment Program.

### BACKGROUND INFORMATION

On March 6, 1986, the City Council authorized, by resolution, the City Manager to submit a Summer Youth Employment Program grant to the Sacramento Employment and Training Agency on behalf of the Department of Parks and Community Services, Recreation Division. The grant has been awarded in the amount of \$71,810. These funds will provide for the administration and supervision of the program. One hundred and sixty (160) employment positions will be available to low income youth in various departments and divisions of the City. Salaries for the youth will be paid directly by SETA (\$150,348).

### FINANCIAL DATA

No additional City funds are required. All costs associated with this program, including some in-house administrative costs, are reimbursable from the awarding of the grant. The City provides in-kind services in the overall program administration and related services.
