

## **RESOLUTION 2023-0222**

Adopted by the Sacramento City Council

June 27, 2023

### **Establishment of a Capital Improvement Project and Acceptance of Clean Air Center Grant Award and Agreement for Resiliency Improvements to the Sam and Bonnie Pannell Community Center**

#### **BACKGROUND**

- A. The City of Sacramento has applied for and been awarded \$228,417 in grant funding from the California Air Pollution Control Officers Association (CAPCOA) Clean Air Center Program for installation of an upgraded air filtration system at the Sam and Bonnie Pannell Community Center (Pannell Community Center).
- B. The City applied to the Federal Emergency Management Agency (FEMA) through the 2023 Pre-Disaster Mitigation (PDM) program (Resolution No. 2023-0086) to secure funding for resiliency improvements as identified through the Fiscal Year 2023 Congressionally Directed Spending Requests.
- C. The project will advance the City's adopted 2021 Local Hazard Mitigation Plan (Resolution No. 2022-0034) and goals of achieving carbon neutrality by 2045, preparing for the effects of climate change, and advancing community resilience (Resolution No. 2019-0433).
- D. CAPCOA has awarded the City of Sacramento \$228,417, and local cost share funding is available from Climate Action Initiatives (I02002300).
- E. The CAPCOA grant is anticipated to serve as required matching cost share for the FEMA PDM project as outlined in the Resolution authorizing the City's FEMA PDM application (Resolution No. 2023-0086).

#### **BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

##### **SECTION 1.**

The City Manager or the City Manager's designee is authorized to accept \$228,417 in grant funding through the CAPCOA Clean Air Center Program for the purposes of installing an upgraded air filtration system at the Sam and Bonnie Pannell Community Center.

## **SECTION 2.**

The City Manager or the City Manager's designee is authorized to execute the agreement to receive the grant and any related documents necessary to support the grant award.

## **SECTION 3.**

The Pannell Community Resiliency Center Project (C15002000) is established as a new Capital Improvement Project.

## **SECTION 4.**

The City Manager or the City Manager's designee is authorized to establish revenue and expenditure budgets of \$228,417 (Other Capital Grants, Fund 3702) in the Pannell Community Resiliency Center Project (C15002000).

## **SECTION 5.**

The City Manager or City Manager's designee is authorized to establish an expenditure budget of \$40,000 (General Fund, Fund 1001) in the Pannell Community Resiliency Center Project (C15002000) with a transfer from the Climate Action Initiatives Program (I02002300) expenditure budget.
