## SUMMARY

It is recommended that the attached agreement be approved authorizing monthly subside payments to SACTO.

## BACKGROUND

The City Council approved \$40,000 in subsidy payments to SACTO from the City's 1984-85 Budget.

## FINANCIAL

The 1984-85 Budget includes \$40,000 for SACTO. The source of funds is the Community Center Fund.
