SUBJECT: Hearing on Assessment, Improvement Proceeding

No. 4886, Jessie Avenue Sewer Assessment District

SUMMARY

The object of the Hearing is to hear any protests against the Assessment District and to confirm the Assessment.

BACKGROUND INFORMATION

The City Engineer filed the Assessment for Improvement Proceeding No. 4886, Jessie Avenue Sewer Assessment District, with the City Clerk on April 2nd, 1980. The improvements constructed under this proceeding consist of a sanitary sewer and sewer services, as described in the Resolution of Intention adopted by the City Council on October 9th, 1979. The City Clerk mailed a Notice of Filing Assessment to each property owner on April 2nd, 1980 and published said Notice in the Sacramento Union on April 4th and 5th, 1980.

FINANCIAL DATA

There is no cost to the City, as all costs are being assessed to the property owners.

RECOMMENDATION

As no protests have been received, it is recommended that the attached Resolution Approving Assessment be adopted.

WHEREAS, this Council, upon the recommendation of the Superintendent of Streets being satisfied with the correctness of said Assessment, Diagram and Engineer's Certificate, hereby finds and determines that said Assessment, Diagram and Engineer's Certificate are true and correct in all respects as filed.

IT IS HEREBY RESOLVED that this Council has heretofore adopted it's Engineer's Report and the same is attached hereto and marked Exhibit "A" and incorporated by reference herein; and that said Assessment, together with the Diagram and Engineer's Certificate attached thereto, be, and the same are hereby confirmed and approved in all respects as filed.

IT IS HEREBY FURTHER RESOLVED that this Council finds that each parcel of land within the assessment district receives a special benefit from the improvements constructed in this proceeding and that each parcel of land within the district is increased in value by reason of said improvements.
