SUBJECT: River Park Little League Lease

### SUMMARY

Pursuant to City Council direction on December 2, 1980 (Resolution No. 80-792), this office has negotiated a lease with the River Park Little League. The lease is in substantially the same form as previous leases approved by the Council.

## BACKGROUND INFORMATION

The City owns Lot A of River Park, Unit No. 8. The River Park Little League, a nonprofit youth service organization, is the current Lessee and has, for nineteen years, been an acceptable steward of the subject parcel. They made the improvements to the site for the operation of baseball activities.

### FINANCIAL DATA

The annual rent is set for \$2.00 for each of the four years of the lease.

#### RECOMMENDATION

The River Park Little League qualifies for a negotiated lease pursuant to the conditions contained in Section 12.39 of the City Code, therefore it is recommended that the City Council, by resolution, authorize the Mayor and City Clerk to execute a lease between the City of Sacramento and the River Park Little League.

### MINUTES

December 22, 1980

Board Members Absent: Larry Saunders, Gil Moreno, Mark Gregson, Joan Aroz, Carol Norman.

Minutes were approved as corrected; the cost of each t-shirt will be \$4.24 instead of \$4.07. Also, Norm Marks asked that Mark Gregson choose between the Yankees and the Red Sox, eliminating the Tigers at this point since those uniforms have no sponsor patches.

Treasurers Report: Al Gutowsky distributed the proposed budget for the coming year. After motion duly made, seconded and carried, the budget was adopted for the 1981 season.

<u>President's Report</u>: Jeff Strimling reported on his correspondence with Robert Rouse from the Department of Community Services regarding the lease on Ciavarella Field. After motion duly made, seconded and carried, the Board gave Jeff authorization to renew the lease with the City of Sacramento.

He will contact them so that they may turn in letters by the next meeting. Bob also reported that with regard to minor league managers, if he does not receive enough requests by the try-outs, he will recruit at that time, with the hope of encouraging new parents to participate.
