Hearing Title: Temporary Street Closure Time Extensions of 108 Alleys/Streets in Council Districts 2, 3, 4, 5 and 6, Proceeding No. TSC22-0001

Location (of project): Council Districts 2, 3, 4, 5, 6 (various locations)

Project Description: Pursuant to the procedures set forth in Sacramento City Code Chapter 12.16 and the authority granted to the City through California Vehicle Code Section 21101.4 the subject alleys/streets were previously temporarily closed to through vehicular and pedestrian traffic due to serious and continual criminal activity. This request for an eighteen (18) month time extension is set forth by Vehicle Code Section 21101.4 and City Code section 12.16. The subject alleys/streets will remain physically closed to through vehicular and pedestrian traffic to help deter criminal activity once the time extension for these subject alleys/streets have been approved by the City Council.

Environmental Determination: Temporary closures of streets and alleys constitutes a minor alteration of a public facility, with no increase in use and no additional automobile lanes. The action is categorically exempt from CEQA review pursuant to CEQA Guidelines section 15301(c). No CEQA review is required.

Prior Commission/Committee/Director Action: Public Works Staff is supportive of the request. The decision to approve the time extension of the temporary closures of the subject alleys to vehicular traffic or pedestrian traffic will ultimately be at City Council's discretion.
