SUBJECT: Museum and History Division - Appropriation Increase for Traveling  
Photography Exhibition

SUMMARY

This report recommends a \$14,500 increase to the FY 1982-83 budget to reflect funds relating to Federal and State grants. The City Council has previously approved application for National Endowment for the Arts funds and California Arts Council funds for the Traveling Exhibition of Historic Photography.

BACKGROUND INFORMATION

The National Endowment for the Arts (NEA) and the California Arts Council (CAC) grant programs assist cultural institutions in publicizing their collections through traveling exhibits.

The Museum and History Division was awarded \$15,000 in 1980 from the NEA to conduct a historic photography survey of the Sacramento Valley. An additional \$20,818 was obtained through private contributions. The Division then submitted applications to both NEA (November 25, 1980) and CAC (March 31, 1981) to fund a traveling photography exhibit featuring the results of this survey. This exhibit, "Commercial Photography of the Sacramento Valley, 1900 - 1940", will culminate a major aspect of the Sacramento Valley Historic Photography Survey, sponsored by the Division in 1980-81. It will represent regional photographers such as David Joslyn, Harold J. McCurry, Merritt Nickerson, Henry and Dulcie Sackrider, Molinario, and Clara Sheldon Smith. The Exhibit is scheduled to appear at the Crocker Art Museum in Yuba City/Marysville, the Haggin Museum in Stockton, and the Oakland Museum in Oakland.

The NEA and CAC grants were awarded and the project is scheduled to begin February 1, 1982 and will terminate April 30, 1982. The grants will enable the Division to commission two photographers to select, print and frame 60 photos for the Exhibit, as well as assist in the development of the catalog. Included in the NEA and CAC budgets is \$4,572 to publish a catalog and an announcement flyer for the exhibition.

FINANCIAL DATA

The \$14,500 project is funded by a \$7,500 grant from National Endowment for the Arts and a \$7,000 grant from the California Arts Council. There is no additional cost to the City.

RECOMMENDATION

It is recommended that the City Council, by resolution, increase appropriations to the Museum and History Division budget by \$14,500 and authorize the City Manager to execute contracts with two of the photographers from the Survey project to prepare the traveling photography exhibit as submitted in the grant application to the National Endowment for the Arts and the California Arts Council.



**RESOLUTION No. 82-091**

RESOLUTION AMENDING THE CITY OPERATING BUDGET FOR FY 1982-83  
FOR THE DEPARTMENT OF COMMUNITY SERVICES AND  
AUTHORIZING THE CITY MANAGER TO EXECUTE TWO  
GRANT-RELATED PROFESSIONAL CONTRACTS

WHEREAS, the Museum and History Division has applied for and been granted funds from the National Endowment for the Arts and the California Arts Council; and

WHEREAS, said funds are to be used to fund a traveling photography exhibit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Sacramento that:

1. The receipt of two grants for the Traveling Photography Exhibit requires an appropriation increase of \$14,500 for the budget of the Department of Community Services.
2. The City budget for FY 1982-83 is hereby amended:  

By adding thereto the sum of \$14,500 to budget number 1-01-2291 relating to the expenditure of funds for the Traveling Photography Exhibit.
3. The above appropriation increase is supported by additional revenues that are forthcoming from the National Endowment for the Arts and the California Arts Council.
4. The City Manager is hereby authorized to execute contracts for professional services of two photographers to perform the work specified in the grants.
