

SUBJECT:

Resolution Authorizing Execution of Agreement Between Frost & Baker, Inc. and the City of Sacramento for the Preparation of Improvement Plans for Norwood Avenue Street Improvements

SUMMARY:

Presented herewith for approval is a consultant services agreement for an amount not to exceed \$28,824,00 between Frost & Baker, Inc. and the City of Sacramento for the preparation of engineering plans for Norwood Avenue Street Improvements from I-880 to Arcade Creek.

BACKGROUND INFORMATION:

This agreement is presented to conform to the guidelines of the policy for Retention of Professional Consultants for City Projects adopted February 26, 1980. The charges shall represent hourly charges for personnel involved in the work, materials, supplies, stakes, mileage, prints needed in the work process plus right of way descriptions, with the total fee not to exceed \$28,824.00.

FINANCIAL DATA;

\$40,000 from Community Development Block Grant "Jobs Bill" funds are available for the subject project. Construction funds will be budgeted in future years.

RECOMMENDATION;

It is recommended that the City Manager and City Clerk be authorized to execute the subject agreement by passage of the attached resolution.
