- 2. ENTITIES--WHETHER GOVERNMENTAL OR OTHER SPECIFIED PARTIES.

The Ordinance permits local programming to be provided in a number of different ways--however, local programming is not a prerequisite for submitting an application nor for award of a franchise. For the purpose of completing this form and others in the Request for Proposals, the applicant is responsible for clearly presenting any proposals relating to local programming. That requires a thorough reading and understanding of the Ordinance and all written interpretations provided pursuant to the Section entitled Clarification of the Franchise Documents of the Request for Proposals adopted by the Cities of Sacramento, Folsom, and Galt, and the County of Sacramento.

The purpose of Form K is to identify in specific terms all the resources committed to local programming for the purpose of evaluating and comparing all applications. The information provided on this form should be presented in such a way that it can be related clearly to corresponding information in other forms. For instance, cost information must be shown so that it is clear that it has been included in Form G: FINANCIAL PRO FORMA. Likewise programming information must be provided in a form that makes it clear it has been included in Form J: PROPOSED SIGNAL CARRIAGE AND CHANNEL ALLOCATIONS. These forms are identified merely as examples and the applicant is responsible to be sure any information that is included on more than one form is clearly presented to verify its inclusion in all the pertinent forms.

Resource commitments to be included on Form K include any proposals made at the discretion of the applicant under the following Ordinance* provisions:

- 5.50.336 ALTERNATIVE NO. 1 ACCESS USE. This is Community Use Programming of a type that permits general public access on a first-comefirst-served basis. For brevity, this section is designated as .336 in this form.
- 5.50.338 ALTERNATIVE NO. 2 FRANCHISEE SPONSORED PROGRAMMING. This
 is Community Use Programming that results from an affirmative effort
 by the Franchisee. For brevity, this section is designated as .338
 in this form.

^{*} All Ordinance references are to the one dated November 24, 1981, enacted by the Board of Supervisors of the County of Sacramento on November 24, 1981.

- 3. 5.50.342 RESOURCES FOR PUBLIC AGENCIES. This section applies only to the Cities and County and deals with more than resources for programming purposes; and it does not require that resources result in programming. However, any resources committed that involve the types of costs information required by Form K should be included. For brevity, this section is designated as .342 in this form.
- 4. 5.50.344 RESOURCES FOR OTHERS. This section applies to any party other than the Cities and County. It requires that the resources be utilized for specific enumerated purposes, and prohibits the utilization thereof for commercial purposes. For brevity, this section is designated as .344 in this form.

In addition, Form K requires information concerning local origination resources.

I. LOCAL ORIGINATION PRODUCTION FACILITIES AND EQUIPMENT

The purpose of this item is to provide information relative to local origination programming facilities and equipment not included on page 19 of Form K relative to Community Use Programming done by the Franchisee under .338.

A. Additional Facilities and Equipment: Provide the following information for all proposed local origination facilities and equipment except local origination facilities and equipment (if any) that are described on Page 19 of Form K.
