SUBJECT: PROPOSED SALARY INCREASE - GOLF COURSE MARSHAL

SUMMARY

This report recommends a 3.85% salary increase for Golf Course Marshal from \$1,458.77 - \$1,773.20 to \$1,514.93 - \$1,841.49 per month. The increase is proposed to compensate for the increased duties and responsibilities of the classification.

BACKGROUND AND ANALYSIS

The duties and responsibilities of the Golf Course Marshal class were increased when the City began hiring Auxiliary Golf Course Marshals on an on-call basis approximately two years ago. Career Golf Course Marshals provide functional supervision and training for Auxiliary Golf Course Marshals and volunteers. In addition, with the growth of the Golf Course Division in recent years, Marshals have assumed responsibility for assisting in the research and preparation of written materials for special projects. Based on these increased responsibilities, a salary increase is warranted.

The proposed salary of \$1,514.93 - \$1,841.49 per month is the same range as Park Maintenance Worker II, a class which requires comparable qualifications and has the same level of responsibility.

The proposed salary range has been agreed to by Local 39.


FINANCIAL DATA

There are two incumbents who will receive a 3.85% salary increase. The increased annual cost will be approximately \$1,638.96 for the two incumbents.

RECOMMENDATION

It is recommended that the City Council amend Resolution 85-998, Section 1, Schedule 03, to increase the salary for Golf Course Marshal by 3.85%.
