SUBJECT: Parking Prohibition on 18th Avenue and 19th Avenue

SUMMARY

This report recommends the placement of "No Parking" signs on the north side of 19th Avenue between 53rd Street and 54th Street and on the south side of 18th Avenue between 53rd Street and 54th Street.

BACKGROUND

These segments of 18th and 19th Avenues are adjacent to Colonial Park. The streets are very narrow (23½' wide) and are unable to provide adequate circulation due to parking congestion.

Impact: This resolution would remove a total of 660' of parking (approximately 24 parking spaces) adjacent to Colonial Park. Parking would remain unrestricted adjacent to the residences opposite the park.

On-street parking adjacent to the east and west sides of the park is unrestricted and can accommodate approximately 32 vehicles.

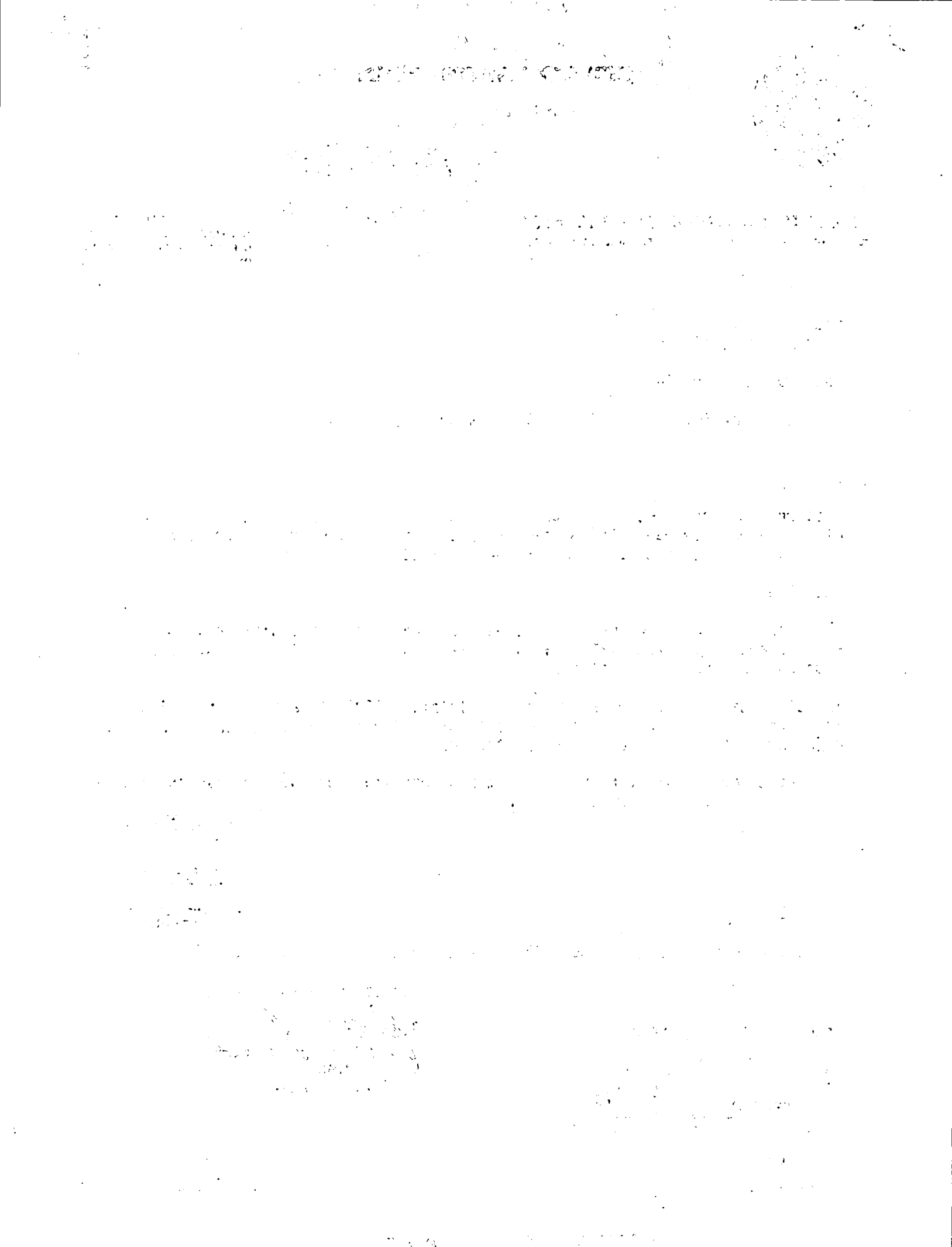

ADOPTED BY THE SACRAMENTO CITY COUNCIL ON DATE OF

A RESOLUTION PROHIBITING PARKING AT ALL TIMES

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

Pursuant to Section 25.101 of the Sacramento City Code when signs are erected giving notice thereof, no person shall at any time park a vehicle upon any of the following described streets or parts of streets:

18th Avenue between 53rd Street and 54th Street, south side only.

19th Avenue between 53rd Street and 54th Street, north side only.
