BACKGROUND INFORMATION

The Sacramento Housing and Redevelopment Agency has requested the abandonment of a portion of the above named Alley in order to consolidate several parcels located on each side of the Alley.

Mr. Alan Richter of Gennis and Associates, Engineers has informed us of the proposed abandonment of all that portion of the alley bounded by 4th Avenue (formerly Cypress Avenue), 5th Avenue (formerly Park Avenue), 35th Street and 36th Street lying South of the prolongation of the northerly lines of Lots 7 and 17 within the City of Sacramento as said alley is shown on that certain Record of Survey entitled "Block's 54, 55, 56, 57 and 58 of Oak Park", recorded in the office of the Recorder of Sacramento County on March 7, 1896 in Book A of Surveys at page 31.

This District is presently occupying this portion of the alley with overhead electric facilities.

However, provided the usual "continuing-use" clause as cited in Section 8330 of the Streets and Highways Code is incorporated in the abandonment ordinance, reserving all rights for the District to construct, reconstruct, operate and maintain electric power line facilities within this alley, we will not object to the abandonment.

RESOLUTION OF INTENTION

NO. 5152

WHEREAS, in the opinion of the City Council of the City of Sacramento, the public interest and convenience require the abandonment of the following described public right of way as provided under the Street Vacation Act of 1941, Streets and Highways Code of the State of California.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Sacramento hereby declares its intention to abandon the following described public right of way in the City of Sacramento:

All that certain real property situate in the City of Sacramento, County of Sacramento, State of California, and being a portion of Block 55, Subdivision E, Oak Park, shown on the plat filed in Book A of Maps at Page 31, Sacramento County Records; said real property being more particularly described as follows: Beginning at the point of intersection of the Northerly right of way line of 5th Avenue (formerly Park Avenue) with the Easterly right of way line of the 20 foot Alley as shown on said plat; thence along said Easterly right of way line North 16° 29' 15" East 369.88 feet to the Northwesterly corner of Lot 17 as shown on said plat; thence leaving last said line North 73° 27' 49" West 20.00 feet to the Northeasterly corner of Lot 7 as shown on said plat; thence along the Westerly right of way line of said 20.00 foot alley, South 16° 29' 15" West 369.89 feet to the point of intersection of last said line with the Northerly right of way line of 5th Avenue as shown on Sacramento Electric, Gas and Railway Company, Oak Park Survey Plat filed in Book 5 of Maps, at Page 16, Sacramento County Records; thence along last said line South 73° 28' 46" East 20.00 feet to the point of beginning and containing 0.17 acre, more or less.

BE IT FURTHER RESOLVED AND ORDERED that on the 23rd day of December, 1980, at the hour of 7:30 o'clock P. M., in the City Council Chambers of the City Council of the City of Sacramento on I Street between 9th and 10th Streets in said City, be, and the same is hereby fixed as the time and place for the hearing on the proposed abandonment of said public right of way.

BE IT FURTHER RESOLVED That the City Clerk be directed to publish notice of hearing of the proposed abandonment of said public right of way in The Daily Recorder, a newspaper published 5 times a week, as required by law, and that said notice be posted along the right of way to be abandoned in accordance with the provisions of the Street Vacation Act of 1941, Sections 8300 to 8324, Streets and Highways Code of the State of California.


