SUBJECT: Addition of Traffic Control Devices in William Land Park

SUMMARY

This report recommends the construction of traffic control gates in six locations within William Land Park to assist the Police Department in restricting access during certain peak hours on Sundays and holidays.

BACKGROUND INFORMATION

The City staff, with the participation of Councilwoman Anne Rudin, has recently concluded meetings with interested citizens concerning the need to restrict parking and access in and around William Land Park on Sundays and holidays. The City staff representation included the Police Department, Traffic Engineering Division, and the Department of Community Services.

On February 12, 1981, a representative group of residents concurred with the staff recommendation to install gates at six locations within Land Park and to restrict parking on Sundays and holidays within Land Park and within residential areas immediately adjacent to the Park. The areas scheduled for traffic control gates are indicated on the attached Exhibit A and are described as follows:

- 1. 12th Avenue at the Riverside entrance to Land Park.
- 13th Street at the south side of the 11th Avenue intersection The city course 2.
- 13th Avenue at the west side of the Land Park intersection. 3.
- 4. 15th Avenue between the Lily Pond and the Zoo.
- 18th Street at the south side of the 13th Avenue intersection. 5.
- 6. 14th Avenue at the west side of the 19th Street intersection.

FINANCIAL DATA

The staff estimates that the cost of construction and installation of the traffic gates will be \$10,000. Additionally, the cost of materials and supplies for the installation of the parking restriction signs is estimated to be \$2,000. The total cost of the project is \$12,000, which is available in General Revenue Sharing funds from another project.

RECOMMENDATION

It is recommended that the City Council, by resolution, approve the construction of the traffic control gates in William Land Park and the transfer of funds to cover the cost of the project.



A RESOLUTION AMENDING THE CITY CAPITAL IMPROVEMENT BUDGET FOR FY 1980-81 FOR THE DEPARTMENT OF COMMUNITY SERVICES (LAND PARK TRAFFIC CONTROL GATES)

BE IT RESOLVED BY THE COUNCIL OF THE CLTY OF SACRAMENTO:

- 1. This project, entitled Land Park Traffic Control Gates, needs an appropriation of \$12,000 for the construction of traffic control gates in six locations within William Land Park.
- 2. The City budget for FY 1980-81 is hereby amended:
 - a. by decreasing \$12,000 from the appropriated Revenue Sharing Fund of the Alkali Flat Project, Budget No. 2-11-2240-1130-4820, for the purpose stated in Paragraph 1 above;
 - b. by increasing \$12,000 from the appropriated Revenue Sharing Fund to the Land Park Project 2-11-2240-2232-4820 for the purpose stated in Paragraph 1 above.
- 3. The above appropriation transfer is supported by funds available in the Revenue/Sharing Fund.

SUBJECT: Repealing Resolution 80-713 and Recommending Prohibiting Parking During Certain Hours on Several Streets Adjacent to and Within William Land Park

SUMMARY

These streets were recommended for restrictions on Sundays and Holidays by the Sacramento Police Department.

BACKGROUND INFORMATION

The City staff has been working with interested citizens regarding parking restriction adjacent to and inside William Land Park. The staff provided testimony and answered questions at a Public Meeting held on November 10, 1980, at the California Middle School. A meeting was held with a citizens' group on February 12, 1981, as a follow-up to the November meeting.

The majority of those in attendance approved the following restrictions on parking. These new restrictions are "No Parking - 8 AM to 11 PM on Sundays and Holidays" on the following streets:

- 1. 11th Avenue between Riverside Boulevard and Land Park Drive on the north side;
- 2. 12th Avenue between 12th Avenue (south) and 13th Street on the south side;
- 3. 13th Avenue between Riverside Boulevard and 14th Avenue on the south side;
- 4. 13th Avenue between 13th Street and 14th Avenue on the north side;
- 5. 13th Street between 12th Avenue and 13th Avenue on the west side;

6. 13th Street between 12th Avenue and a point 750 feet south of 13th Avenue on the east side;

7. 14th Avenue between Land Park Drive and the east leg of 18th Street on the north side;

FINANCIAL DATA

A separate communication to the Council from the Department of Community Services will address the financial aspects.

RECOMMENDATION

It is recommended the Council repeal Resolution 80-713 and approve the attached Resolution that prohibits parking during certain hours.

A RESOLUTION PROHIBITING PARKING DURING CERTAIN HOURS

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1.

Pursuant to Section 25.103 of the Sacramento City Code when signs are erected giving notice thereof, no person shall stop, stand, or park any vehicle upon any of the following described streets or parts of streets between the hours specified on said signs.

Balboa Circle;

Bidwell Way between Freeport Boulevard and 19th Street on the north side only;

Bidwell Way between Freeport Boulevard and the Western Pacific tracks on the south side only;

Caleb Avenue between Sandburg Drive (West) and Sandburg Drive (East);

Carlson Drive between Sandburg Drive (North) and State Avenue;

Cisco Circle;

Colonial Way between Stockton Boulevard and Sherman Way;

E Street between Coloma Way and 270' Easterly;

Freeport Boulevard between 4th Avenue and Sutterville Road;

Hale Court;

J Street between 7th and 8th Streets; on the north side only;

only;

13th Avenue between Land Park Drive and Freeport Boulevard on the north side only;

<u>13th Avenue between Riverside Boulevard and 14th Avenue on the</u> south side only; <u>13th Avenue between 13th Street and 14th Avenue on the north</u> side only;

13th Street between 12th Avenue and 13th Avenue on the west side only;

13th Street between 12th Avenue and a point 750 feet south of 13th Avenue on the east side only;

<u>14th Avenue between Land Park Drive and the east leg of 18th</u> Street on the north side only;

24th Street between Broadway and 1st Avenue on the east side only;
