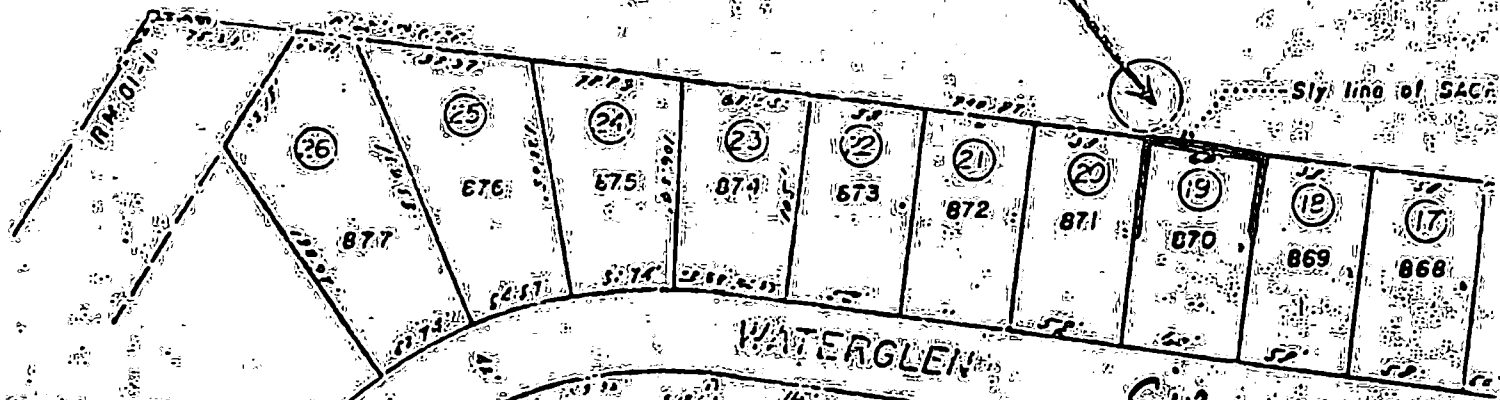

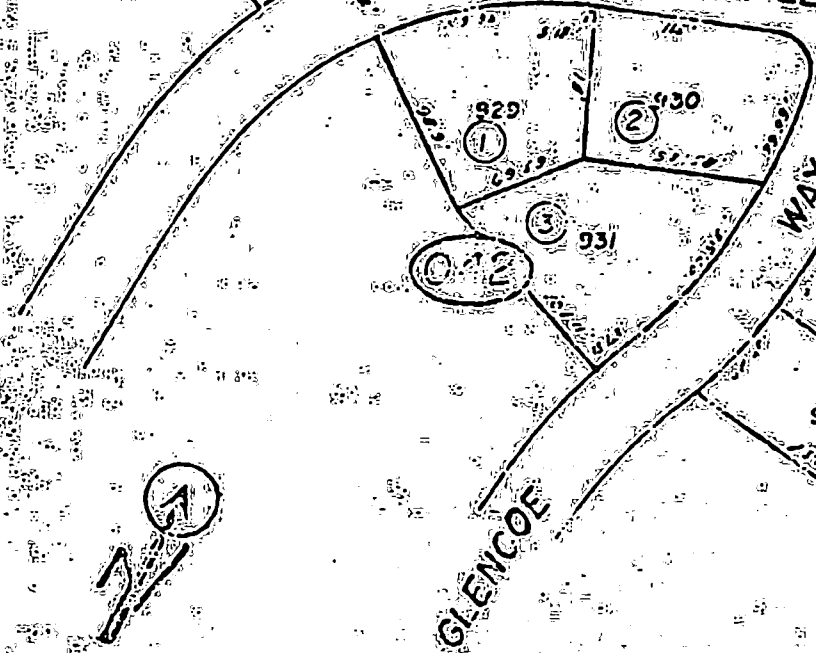

RESOLUTION OF INTENTION NO. 5121

VACATING PUBLIC RIGHT OF WAY AND
EASEMENT PURSUANT TO SECTIONS 50430
TO 50442, INCLUSIVE, OF THE GOVERNMENT
CODE OF THE STATE OF CALIFORNIA

WHEREAS, a certain public right of way and easement, herein-
after specifically described, is not now necessary for the purpose for
which said easement was dedicated; and

WHEREAS, the City Council of the City of Sacramento is of the
opinion that public interest and convenience require the vacation of said
easement.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the
City of Sacramento hereby declares its intention to abandon the Public
Utility Easement along the Northerly ten (10) feet of Lot 870 of Glenbrook
Unit No. 9.

BE IT FURTHER RESOLVED AND ORDERED that the 23rd day of
September, 1980, at the hour of 7:30 o'clock P. M. in the Council Chamber
of the City Council of the City of Sacramento, in the City Hall on I Street
between 9th and 10th Streets in said City, be and the same is hereby fixed
as the time and place for the hearing of the proposed vacation of said
Public Utility Easement above described.

BE IT FURTHER RESOLVED that the City Clerk be directed to publish
Notice of Hearing of the proposed vacation of said Public Utility Easement
in the Daily Recorder, a newspaper published five times a week, as required
by law, and that said Notice be posted along said right of way and easement
to be vacated in accordance with the provisions of Sections 50440 and 50441
