Subject: **STORM DRAINAGE FEE REFUND**

SUMMARY

This report requests that the Budget and Finance Committee recommend that the City Council adopt the attached resolution that authorizes a \$13,868.52 refund for erroneously billed storm drainage charges.

BACKGROUND

Resolution No. 84-149 adopted February 21, 1984 authorizes the Director of Finance or her designee to approve refund claims for City utility service charges in the event:

1. The claim for refund is valid;
2. The claim is presented within three years from the date of the disputed billing; and
3. The claim is for \$10,000 or less.

On May 31, 1988 staff discovered that the City was erroneously overbilling storm drainage fees at 7311 Greenhaven Drive. The amount overbilled for three years prior to May 31, 1988 is \$13,868.52. The overbilling was caused by an incorrect calculation of the square footage of the commercial parcel.


DISCUSSION

The \$13,868.52 overbilled exceeds staff's authority for refund approval.

The Budget and Finance Committee recommends that the City Council adopt the attached resolution that authorizes a \$13,868.52 refund for erroneously billed storm drainage charges.


DISCUSSION
