This is to acknowledge the filing of your claim with this office on May 19, 1982.


We are sending this notice pursuant to Government Code Section 910.8 to advise you that your claim filed against the City of Sacramento is insufficient in the following respect:

DEAR COUNCIL:

THIS LETTER IS ADDRESSED TO YOU PURSUANT TO CALIFORNIA GOVERNMENT CODE SECTION 900 ET SEQ.

I AM THE OWNER OF THE REAL PROPERTY LOCATED AT 415 - 15TH STREET, SACRAMENTO, CALIFORNIA.

ON OR ABOUT MARCH 1, 1980, WHILE DOING CONSTRUCTION ON SAID PROPERTY, I ACCIDENTLY RUPTURED A SEWER LINE CROSSING MY PROPERTY PURSUANT TO A PRESCRIPTIVE EASEMENT IN FAVOR OF RONALD G. AND CECILIA MARIE DAVIS, OWNERS OF THE PROPERTY LOCATED AT 401 AND 403 - 15TH STREET, SACRAMENTO, CALIFORNIA.

ABC PLUMBING WAS HIRED TO REPAIR THE DAMAGED SEWER LINE. IN THE PROCESS OF REPAIRING SAID SEWER LINE, THE CITY OF SACRAMENTO, DEPARTMENT OF PUBLIC WORKS CAUSED THE SEWER LINE TO BE UNNECESSARILY REROUTED OVER MY PROPERTY WITHOUT MY CONSENT OR PERMISSION.

I CONTEND THAT THE REROUTING WAS NOT NECESSARY, AND THAT IF IT WAS, MY WRITTEN CONSENT OR PERMISSION WAS REQUIRED BEFORE SO DOING.

AS A RESULT OF THE ABOVE-STATED ACTION BY THE SACRAMENTO DEPARTMENT OF PUBLIC WORKS, I SUFFER CONTINUING TRESPASS ON MY PROPERTY, I SUFFER INTERFERENCE WITH MY DEVELOPMENT OF SAID PROPERTY, AND A LEGAL ACTION HAS BEEN FILED AGAINST ME TO RECOVER A SUM OF \$4,000.00 FOR REPAIRS TO THE SEWER LINE.

BASED ON THE ABOVE, I CLAIM THAT THE CITY OF SACRAMENTO IS LIABLE TO ME IN THE AMOUNT OF \$5,000.00.
