SUBJECT: Revocable Encroachment Permit - KOVR - Channel 13

1236 Arden Way & 1216 Arden Way, Sacramento

SUMMARY:

KOVR - Channel 13, has applied for a revocable encroachment permit for the purpose of extending telephones lines across Blumenfeld Drive @ Arden Way. The Director of Public Works recommends that the permit be granted.

BACKGROUND:

The area for which this request is being made consists of an area across Blumenfeld Drive overhead. A cable to connect 1216 Arden Way & 1236 Arden Way - Approximately 40 feet.



SPECIAL CONDITIONS

1.	All construction shall conform to P.U.C. General Order 95. In no case shall the cable fall lower than the top of the traffic signal
	at the intersection if cable is within 100 ft. of the intersection.
