Subject: Modification to Contract for Janitorial Services for

SUMMARY

The contract for Janitorial Service was awarded to three contractors for various City facilities. Two of the contracts require increased funding due to additional requirements. The total increase for the remainder of this contract period is \$3,721.97.

BACKGROUND INFORMATION

Formal Bid No. 723 was solicited by the City Council and subsequent awards made to the three most responsive, responsible bidders.

a.	Tom's Maintenance	\$23,400.00
b.	Nam Shik Kim	\$27,440.00
С.	Quick & Clean Janitorial	\$50,448.00

The proposed increase will be applied as follows:

a.	Tom's Maintenance (1,964.60)	\$25,364.60
b.	Quick & Clean Janitorial (\$1,757.37)	\$52,205.37
