The City Engineer's office has prepared plans and specifications for the subject project. Copy of said plans and specifications has been forwarded to the City Clerk and approval is recommended.

FINANCIAL DATA:

In F.Y. 1977/78 the City Council approved in the Engineering Budget, \$110,500.00 of Gas Tax funds for the subject project. Total amount currently available for this project is \$40,086.39. The current estimated construction cost is \$5,940.00.

The City Engineer recommends that the plans and specifications be approved and that bids be received on June 9, 1981.

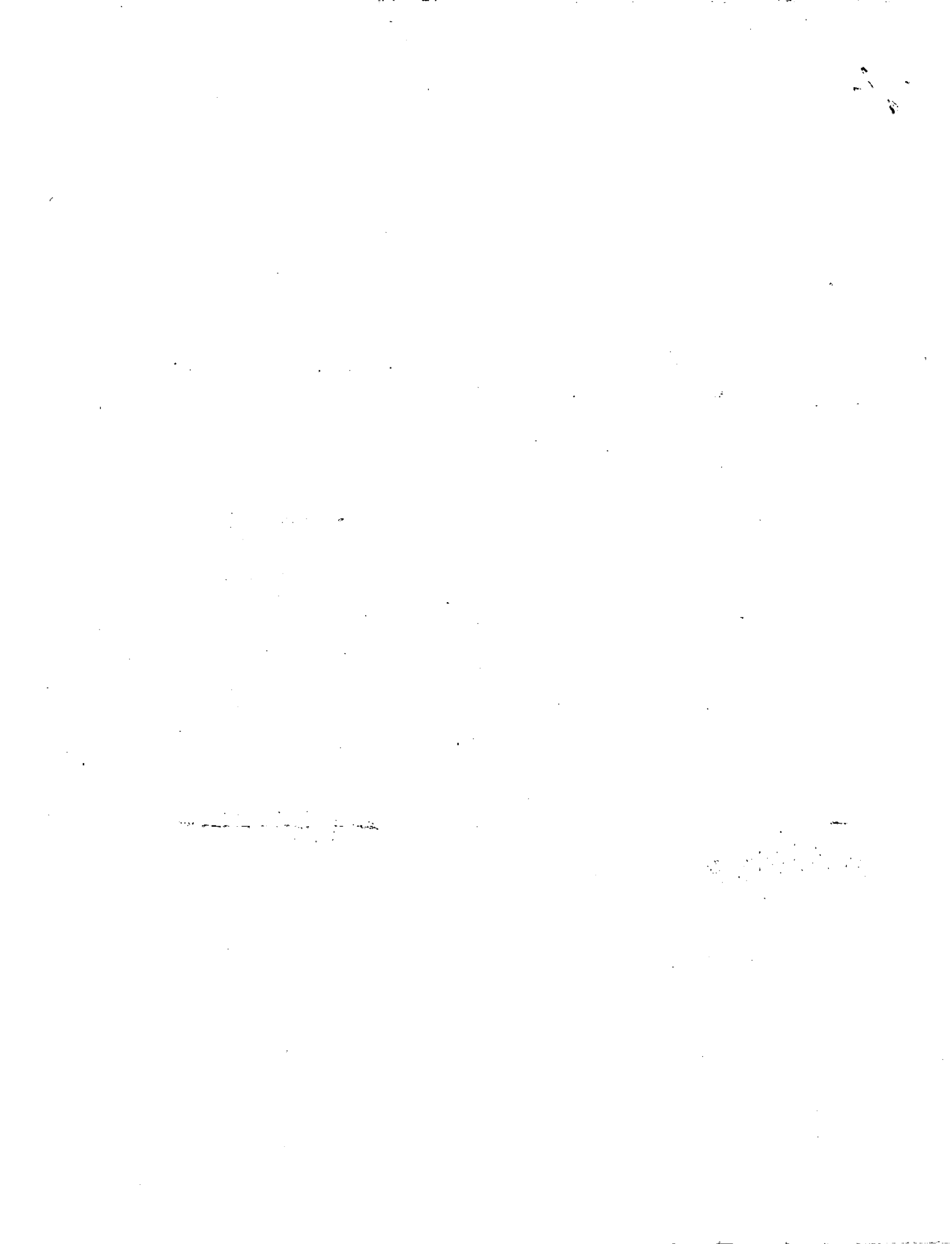
