SUBJECT:

Resolution Appropriating \$95,537 from the Transportation Development Act to the Sacramento River Bikeway and the

Sacramento Northern Railroad Bikeway

SUMMARY:

On December 16, 1980 the City Council approved the 1980/81 Annual Transportation Claim for \$95,537 to be used to fund the Sacramento River Bikeway and the Sacramento Northern Railroad Bikeway. The claim has been submitted and approved by the Sacramento Area Council of Governments (SACOG), formerly known as SRAPC, and the appropriation of \$95,537 from the Transportation Development Act is recommended.

FINANCIAL:

The appropriation of \$95,537 from the Transportation Development Act will provide \$50,000 for the Sacramento River Bikeway and \$45,537 for the Sacramento Northern Railroad Bikeway.

RECOMMENDATION:

It is recommended that \$95,537 be appropriated from the Transportation Development Act to the Sacramento River Bikeway and the Sacramento Northern Railroad Bikeway, by passage of the attached resolution.

A RESOLUTION AMENDING THE CITY BUDGET FOR F.Y. 1980/81 FOR THE SACRAMENTO RIVER BIKEWAY AND THE SACRAMENTO NORTHERN RAILROAD BIKEWAY

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

- 1. The 1980/81 Annual Transportation Claim for \$95,537 to be used to fund the Sacramento River Bikeway and the Sacramento Northern Railroad Bikeway has been submitted and approved by the Sacramento Area Council of Governments. This appropriation is necessary to provide funding for these bikeways.
- 2. The City Budget for Fiscal Year 1980/81 is hereby amended by appropriating \$95,537 from the unappropriated fund balance of the Transportation Development Act (2-35) to the Community Services Department's Budget as follows:
 - a. \$50,000 to the Sacramento River Bikeway project (2-35-2240-1166-4820) and;
 - b. \$45,537 to the Sacramento Northern Railroad Bikeway (2-35-2240-1199-4820) for the purpose stated in Paragraph 1 above.
