SUBJECT: Sacramento Zoo Food Concession Contract

SUMMARY

This report recommends the award of a contract for the Sacramento Zoo Food Concession to Jax Catering.

BACKGROUND INFORMATION

The existing contract between the City and Jax Catering to provide food concession services at the Sacramento Zoo expires on February 29, 1980. The City Clerk received one (1) bid on February 5, 1980. The bid is by the current concessionaire, Jax Catering, a partnership of Camilla P. Mulligan and Terrance J. Mulligan.

FINANCIAL DATA

The existing contract provides a concession fee to the City of 37.0% of the gross receipts per year. The recommended contract is for three (3) years and provides 36.5% of the gross receipts per year.

RECOMMENDATION

The Jax Catering is in compliance with all of the bid requirements of the City. Pursuant to the provisions of Chapter 12, Article III of the Sacramento City Code, it is recommended that the City Council award the concession contract to Jax Catering at a contract fee of 36.5% of the gross receipts of the Sacramento Zoo Food Concession.
