SUBJECT: Authorization to Solicit Bids and Contract Awards - Phase XI Modernization

#### SUMMARY

The attached resolution authorizes solicitation of bids, award and execution of contracts with the lowest responsible bidders in accordance with the plans and specifications for the following under Phase XI Modernization:

- lawn sprinkler system, Cal 5-1, New Helvetia Housing Project;
- 2) emergency lighting in halls, stairwells and exits, Cal 5-10, 2516 H Street;
- 3) emergency lighting in halls, stairwells and exits, Cal 5-11, 3543 lst Avenue;
- 4) installation of panic hardware on exterior lobby doors and installation of air conditioning to lobby areas, Cal 5-12, 2845 37th Street; and,
- 5) re-roof two buildings, Cal 5-15, 480 Redwood Avenue.

A copy of the plans and specifications is on file with the City Clerk's office.

#### BACKGROUND/FINANCIAL DATA

The application for Phase XI Modernization funding was approved by the Housing Author 15 of the City of Sacramento on April 1, 1980, by Resolution HUMBERT 1788.
