SUBJECT: Contract for Use of California Highway Patrol Facilities

## SUMMARY

The attached resolution will allow the City Manager to sign a contract for use of the California Highway Patrol facility to train Police Cadets and Community Service Officers.

#### BACKGROUND INFORMATION

Since 1971 the Police Department has been using the Highway Patrol Academy facilities to train new Police Officers and Community Service Officers.

The contract, which is for meals and lodging, is exactly the same as those approved in the past.

#### FINANCIAL DATA

The cost for meals and lodging for a recruit for eleven weeks is \$1,930.50. The Commission on Peace Officers Standards and Training will pay for ten weeks of lodging and meals or \$1,751.00. The amount not reimbursed equals \$179.50 per City recruit.

We estimate that there will be eight positions to fill in the Police Department which means that the total non-reimbursable cost to the City is \$1,436.00. If we have more positions open before the academy starts, this figure would increase by \$179.50 per position.

Outside agencies who train in our academy are billed for and pay for the full eleven weeks of meals and loding, or \$1,930.50 for each trainee. The payments are credited to the general fund.

The maximum spaces available from the California Highway Patrol are for forty recruits.

The per diem costs at the Highway Patrol Academy increased after the Police Budget was approved. If the class is at the maximum size of 40 recruits and all recruits complete the course there would not be sufficient funds in the budget line to cover the entire contract. There will be sufficient funds within the police budget however and no augmentation to the Police Budget will be necessary. Also, the reimbursement from the State for per diem costs covers the CHP increase and this will be reflected in increases paid to the general fund from P.O.S.T.

### RECOMMENDATION

Resolution be passed to allow for signing of contract.

# RESOLUTION NO. 82-097

#### ADOPTED BY THE SACRAMENTO CITY COUNCIL ON DATE OF

RESOLUTION AUTHORIZING THE EXECUTION OF CONTRACT WITH THE STATE OF CALIFORNIA HIGHWAY PATROL FOR USE OF THE HIGHWAY PATROL ACADEMY

WHEREAS, the Sacramento Police Department desires to undertake Basic Recruit Officer Training Classes for the period March 22, 1982 through June 18, 1982.

WHEREAS, the Sacramento Police Department intends to utilize the facilities of the California Highway Patrol Academy for such classes.

WHEREAS, the Sacramento Police Department will act as the fiscal agent for other public agencies desiring to utilize the Highway Patrol Academy for Basic Recruit Officer Training classes.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SACRAMENTO:

That the City Manager is hereby authorized to execute a contract with the State of California Highway Patrol for Basic Recruit Officer Training classes. The City Manager is authorized to execute all necessary subsidiary agreements with other public law enforcement agencies using the Highway Patrol Academy for training purposes. The City Manager is further authorized to delegate his authority to execute said subsidiary agreements to the Chief of Police. If such authority is delegated, the Chief of Police is authorized to execute said subsidiary agreements.
