### BACKGROUND INFORMATION

The Council awarded a contract to Teichert Construction on June 12th, 1979 for constructing concrete curbs, gutters and sidewalks, asphaltic concrete pavement, storm sewers, drainage facilities, street lighting system complete and reconstruct water distribution system in the above named Assessment District. At the time of signing the contract, the completion date was scheduled for April 19th, 1980, however, the work will not be finished by that time due to rainy weather delaying commencement of the work.

### RECOMMENDATION

It is recommended therefore, that the Council grant an exentsion of 180 days to Teichert Construction by adoption of the attached Resolution Extending Time On Contract.
