SUMMARY

The City has received an application amending the Delta Shores Planned Unit Development. It is recommended that a contract be authorized with Nichols-Berman Consultants for \$76,000 to complete the Subsequent EIR for this proposed project.

BACKGROUND INFORMATION

An initial assessment of the proposed amendment to the Delta Shores Planned Unit Development has determined that an Environmental Impact Report is required. Delta Shores is located approximately 1 mile south of Meadowview Road on I-5 and adjacent to the town of Freeport. Current City policy is to have EIR's prepared by outside consultants.

Staff, in agreement with the project proponent, recommend an agreement with Nichols-Berman. The firm has prepared the previous environmental documents for the Delta Shores project, is familiar with the issues and can produce the Subsequent EIR in a timely manner. Staff has evaluated the work required of the consultant and has determined that the price provided by Nichols-Berman is competitive with industry standards. In consideration of these factors, no other bids were solicited.

FINANCIAL INFORMATION

The Consultant cost to prepare the Subsequent EIR is projected to be \$68,585. A contingency of \$7,415 is recommended to provide additional analysis that may be required as the study progresses, which results in a potential total consultant cost of \$76,000. This cost will be paid from a deposit by the developer. No additional appropriation of City funds is required.


