SUBJECT: Resolution Authorizing Execution of Agreement Between Metropolitan

Civil Engineering Company and the City of Sacramento for the Preparation of Improvement Plans for Del Paso Heights Street Assessment District No. 6

SUMMARY:

Presented herewith for approval is a consultant services agreement for an amount not to exceed \$35,000 between Metropolitan Civil Engineering Company and the City of Sacramento for the preparation of engineering plans for the Del Paso Heights Street Assessment District No. 6.

BACKGROUND:

This agreement is presented to conform to the guidelines of the policy for Retention of Professional Consultants for City Projects adopted May 10, 1977. The charges shall represent hourly charges for personnel involved in the work, materials, supplies, stakes, mileage and prints needed in the work process, with the total fee not to exceed \$35,000.

FINANCIAL:

Funds are available from the City Engineer's Operating Budget for 1980/81. The 1980/81 Capital Improvement Budget also includes \$45,000 from Community Development Block Grant funds for the subject project.

RECOMMENDATION:

It is recommended that the City Manager and City Clerk be authorized to execute the subject agreement by passage of the attached resolution.
