SUBJECT: Resolution Certifying the Final E.I.R. for the Solid Waste Disposal Alternatives

SUMMARY:

Submitted is the final E.I.R. for the Solid Waste Disposal Alternatives. It is recommended that the City Council approve the final E.I.R. by passage of the attached resolution.

BACKGROUND:

The firm of Brown and Caldwell was selected to prepare a draft E.I.R. for the Solid Waste Disposal Alternatives. The draft E.I.R. was prepared in accordance with the Guidelines for Implementation of the California Environmental Quality Act (CEQA). A Notice of Completion was filed with the State of California Secretary for the Resources Agency and public notice was given that the draft E.I.R. had been completed (in conformance with CEQA guidelines). A public hearing on the draft E.I.R., as required by the City of Sacramento Environmental Regulations, was held before the Planning and Community Development Committee on November 20, 1980.

A final E.I.R. has been prepared, which includes the draft E.I.R., comments to the draft E.I.R., and responses to those comments. The final E.I.R. is herewith being submitted for Council consideration.


RECOMMENDATION:

It is recommended that the City Council certifies that the Solid Waste Disposal Alternatives final E.I.R. has been completed according to the California Environmental Quality Act and the State guidelines by passage of the attached resolution.

RESOLUTION CERTIFYING THE FINAL E.I.R. FOR THE SOLID WASTE DISPOSAL ALTERNATIVES HAS BEEN COMPLETED IN COMPLIANCE WITH CEQA AND THE STATE GUIDELINES

WHEREAS, the City proposed a project to select an alternative to replace the existing City landfill site.

WHEREAS, the City caused to be prepared by Brown and Caldwell a draft E.I.R. for the Solid Waste Disposal Alternatives.

WHEREAS, a Notice of Completion was filed with the State of California Secretary for the Resources Agency and Public notice was given that said draft E.I.R. had been completed, all in conformance with applicable law and regulations; and,

WHEREAS, a public hearing on said draft E.I.R. was held by the Planning and Community Development Committee of the City Council on November 20, 1980; and,

WHEREAS, written comments on the draft E.I.R. were received and public testimony with respect to said draft E.I.R. was received in said hearing on November 20, 1980; ,

WHEREAS, a final E.I.R. for the proposed project was subsequently prepared incorporating said draft E.I.R. and comments and appropriate responses thereto all according to pertinent law and regulations; and,

WHEREAS, said final E.I.R. has duly and properly been presented to the Council for certification;

THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That the City Council of the City of Sacramento, as a decision-making body of the City of Sacramento as lead agency certifies that the final E.I.R. for the Solid Waste Disposal Alternatives has been completed in compliance with CEQA and the State Guidelines.

Council Members:

On January 11, 1982, members of the Joint City-County Solid Waste Advisory Committee received copies of the City's Final Environmental Impact Report on Solid Waste Disposal Alternatives. Attached to this report is a letter from R.H. Parker which states that your Council will hold a hearing on the adequacy of the E.I.R. on January 19, 1982. Our committee requests that you postpone a hearing on this item for 30 days. This will allow our committee and other interested parties sufficient time to review the report and to provide comments.

The Solid Waste Advisory Committee was created by City and County ordinances in October, 1979 with the charge to advise the County Board of Supervisors and the City Council on solid waste matters. We are concerned that City staff has not allowed sufficient time for review of the E.I.R. so that we may fulfill our responsibilities to your Council. Since we reviewed the draft E.I.R. in October, 1980, and provided comments at a hearing before the City Planning Commission, we would like the opportunity to review the adequacy of the responses to those comments in the final E.I.R. To reiterate, SWAC requests that you delay a hearing on this for 30 days.
