Adopting the Amended 2025 Meeting Schedule for The City of Sacramento Utility Users Tax Appeals Board

BACKGROUND

- A. The Ralph M. Brown Act (California Government Code 54950 et seq.) requires that legislative bodies provide the time and place for regular meetings by ordinance, resolution, bylaws, or by whatever other rule is required for the conduct of business by that body.
- B. The City of Sacramento observes the following holidays: New Year's Day, Martin Luther King, Jr. Day, Presidents' Day, Cesar Chavez Day, Memorial Day, Independence Day, Labor Day, Veterans Day, Thanksgiving Day, Day after Thanksgiving, Christmas Eve (half day), Christmas, and New Year's Eve (half day). The City of Sacramento shall refrain from holding legislative meetings on the following additional holidays: Passover, Juneteenth, Rosh Hashanah, Yom Kippur, Native American Day, Indigenous Peoples' Day, Halloween, and Hanukkah.
- C. City Council recess is at least two weeks in July and December. No legislative meetings are held while the City Council is on recess.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

SECTION 1.


