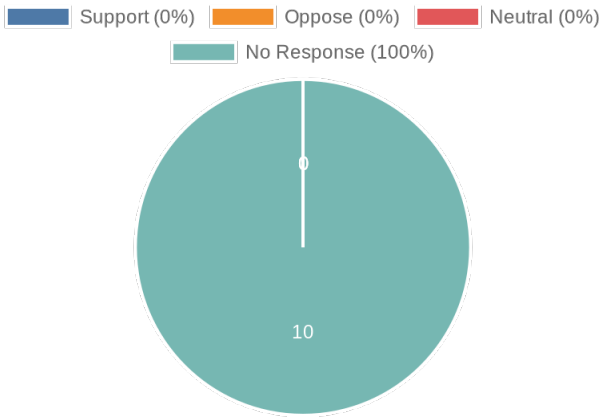

Overall Sentiment



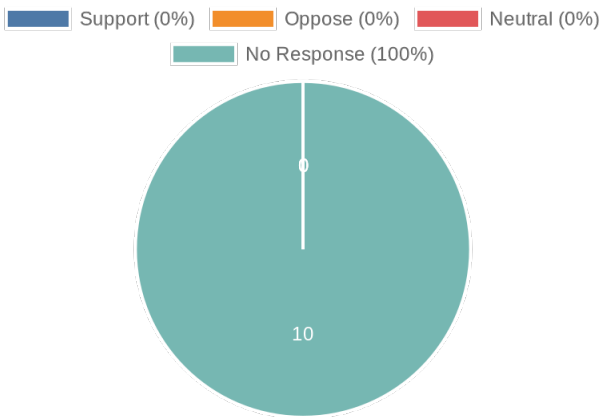

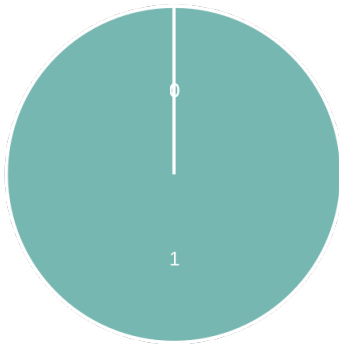
Overall Sentiment
