SUBJECT: Robla Viejo Assessment District (JN:20AD) - Authorizing
Execution of Consent Agreement For Right-of-Way With
Department of the Air Force

SUMMARY

It is requested that the City Council adopt a resolution authorizing the City Manager and the City Clerk to execute an agreement with the Department of the Air Force for right-of-way in the Robla Viejo Assessment District.

BACKGROUND

In the Robla Viejo Assessment District eminent domain action to acquire a twenty foot right-of-way on the Garrette parcel there exists an easement to the United States for a drainage ditch or drainage pipeline.

This easement is over a portion of the proposed City right-of-way. The Department of the Air Force will sign a consent agreement for common use of the parcel, but will require the City to execute the document before they sign the agreement.
