SUMMARY

SUBJECT: UPARR Program Grant

SUMMARY

This report requests acceptance of a grant from the National Park Service for Urban Park and Recreational Recovery Program (UPARR) to finance a Volunteer Recruitment and Training/Cost Recovery Analysis Program. A budget amendment is required.

BACKGROUND INFORMATION

The City Council approved, on August 26, 1986, the submittal of an Urban Park and Recreational Recovery Program grant application for funding to finance a Volunteer Recruitment and Training/Cost Recovery Analysis Program. Urban Parks and Recreation Recovery Program grants provide funds to develop local Recovery Action Programs designed to revitalize parks and recreational facilities. Particular emphasis is on encouraging private sector support, systematic planning at the local level including widespread citizen involvement, and the development of linkages with non-municipal area recreation and service providers. These federal grants are allocated on a competitive basis.

The Department has been notified that its \$37,065 grant proposal for funding of the Volunteer Recruitment and Training/Cost Recovery Analysis Program was successful. The Program directly relates to goals stated in the 1984 Parks and Recreation Facilities Master Plan, which clearly indicates the need to secure supplemental support funds of park and recreational services and facilities, as well as the establishment of a formal volunteer service program to increase the opportunities for public involvement. A volunteer recruitment and training program and a cost recovery analysis program relate directly to these goals, and are necessary to realize the mandates of the master plan. The understanding and development of both of these areas have enormous implications for our own operations as well as to our peers working with similar operations.

FINANCIAL DATA

The total cost of the Volunteer Recruitment and Training/Cost Recovery Analysis Program is \$79,423. The grant will reimburse the program up to \$37,065. City matching funds in the amount of \$42,358 for in-kind services and consulting services were appropriated in the Department's FY 1986-87 operating budget. No additional City funds are required to support this grant.

RECOMMENDATION

It is recommended that the Committee approve the acceptance of the UPARR grant for funding of a Volunteer Recruitment and Training/Cost Recovery Analysis Program and amend the Department of Parks and Community Services operating budget by a \$37,065 increase. Further, it is recommended that the Committee forward this report to the full City Council for approval.
