NOTICE IS HEREBY GIVEN that the City Council of the City of Sacramento (City Council) and the Redevelopment Agency of the City of Sacramento (Agency) will hold a joint public hearing on Tuesday, October 6, 1998, at 2:00 p.m., in the City Council Chambers, located at City Hall, 915 "I" Street, Sacramento, California, to consider and act upon the proposed First Amendment (First Amendment) to the Redevelopment Plan (Redevelopment Plan) for the Sacramento Army Depot Redevelopment Project Area (Project Area) and to consider all evidence and testimony for or against the approval and adoption of the proposed First Amendment. At any time not later than the hour set forth above for the hearing of comments on or objections to the proposed First Amendment, any person may file in writing with the City Clerk of the City of Sacramento a statement of objections to the proposed First Amendment. At the day, hour, and place of the hearing, any and all persons having any comments on or objections to the proposed First Amendment, or who question the regularity of any of the prior proceedings, may appear before the City Council and the Agency and show cause why the proposed First Amendment should not be adopted.

The purpose of the proposed First Amendment is to exclude certain land (Excluded Areas) from the boundaries of the Project Area. No other changes to the Redevelopment Plan are proposed.

The legal description of the boundaries of the existing Project Area is recorded in Book 95-06-29, Page 0718 of the Official Records of the County of Sacramento. The legal description of the land within the proposed Excluded Areas is contained in Exhibit A, attached hereto and made a part hereof. For informational purposes, a map showing the general location in the City of the existing Project Area and the proposed Excluded Areas is attached hereto as Exhibit B and made a part hereof.

NOTICE IS HEREBY FURTHER GIVEN that, concurrently with the joint public hearing of the City Council and the Agency on the proposed First Amendment, the Agency will also hold a public hearing and hear testimony of all interested parties for the purpose of considering a proposed First Amendment to the Implementation Plan for the Project.

Interested persons may inspect and, upon payment of the costs of reproduction, obtain copies of the proposed First Amendment to the Redevelopment Plan, the Agency's Report to the City Council on the proposed First Amendment to the Redevelopment Plan, the proposed First Amendment to the Implementation Plan, and any other information pertaining thereto at the office of the Sacramento Housing and Redevelopment Agency, 630 "I" Street, Sacramento, California.



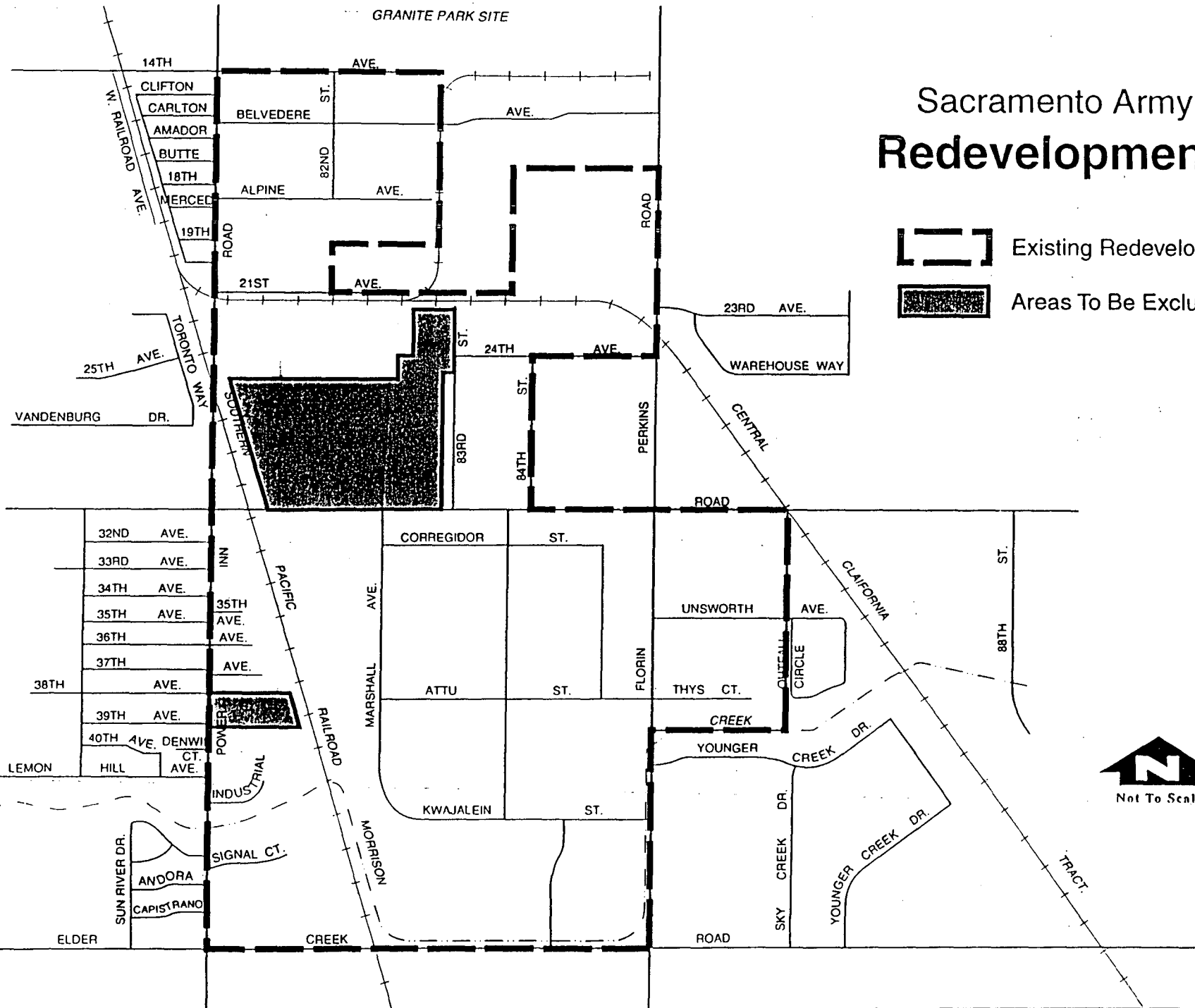
