RESOLUTION NO. 82-302

ADOPTED BY THE SACRAMENTO CITY COUNCIL ON DATE OF
MAY 6TH, 1982

APPROVING FINAL PARCEL MAP FOR LOT 222, ACME ACRES (P-9425)

WHEREAS, THE COUNCIL OF THE CITY OF SACRAMENTO FINDS AND DETERMINES
AS FOLLOWS:

A. The final Parcel Map of Lot 222, Acme Acres, together with provisions for its design and improvement, is consistent with the General Plan of the City of Sacramento and the Robla Community Plan.

B. The final map is in substantial compliance with the previously approved tentative map.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY
OF SACRAMENTO AS FOLLOWS:

1. The final map of Lot 222, Acme Acres, be, and the same is hereby approved subject to the execution by all parties of the parcel improvement agreement.

2. All offers of dedication shown on said map are hereby accepted, subject to the improvement thereof required by the parcel agreement.

3. The City Manager and City Clerk be authorized and directed to execute on behalf of the City of Sacramento an agreement between the City and Alvin Brenneise and Luella Brenneise. Said Agreement requires that the present owners and any successor in title will participate any future assessment district that affects said Parcel Map, thereby waiving their

4. The Real Estate Supervisor is authorized and directed to record the abstract of the above mentioned agreement in the official records of Sacramento County.
