OF PROCESS IN ACTIONS AGAINST THE CITY FOR PROPERTY TAX

SUMMARY

The County Counsel currently defends actions against the City seeking property tax refunds. State law now requires that the City designate the County as its agent for service of process if the City wishes to continue to provide for its defense by the County Counsel in such actions. The attached resolution would so provide.

BACKGROUND

The City of Sacramento has had the Sacramento County Counsel defend actions against the City seeking property tax refunds. This procedure has been in accordance with Revenue and Taxation Code Section 5149.

Section 5149 has recently been amended (effective January 1, 1982) to require that the City designate the County as its agent for service of process in such actions if the City wishes to provide for its defense by the County Counsel. The County may impose fees upon the City to defray its incurred costs. The City may withdraw its designation of the County at any time.

The attached resolution designates the County as the City's agent for service of process in property tax refund actions against the City. Its adoption is necessary if the City wishes to continue its practice of providing for defense of the City by the County Counsel in such actions.
