SUBJECT: Resolution Authorizing Execution of an Amendment to Agreement Between City of Sacramento and The Spink Corporation for the Preparation of Improvement Plans for Fruitridge Road Between Power Inn Road and the Central California Traction Railroad Tracks

SUMMARY:

The subject amendment covers additional engineering design services beyond the scope of the original contract. Approval of this amendment is recommended.

BACKGROUND:

On December 1, 1981, the City Council approved the agreement for the preparation of improvement plans for the subject project by adoption of Resolution No. 81-887. The original agreement was for a not to exceed amount of \$37,100 plus right-of-way descriptions and title reports. This is a Federal Aid Urban (FAU) project and construction will be financed with 86% Federal funds.

The subject amendment covers additional required services beyond the scope of the original contract. These services are outlined in detail in the attached amendment.

FINANCIAL:

The proposed amendment is in the amount of \$15,586. The 1981/82 and 1982/83 Capital Improvement Program includes \$140,000 for the subject project from Major Street Construction funds. As of October 1, 1982, the unencumbered balance is \$83,973.

RECOMMENDATION:

It is recommended that the City Manager and City Clerk be authorized to execute the amendment by passage of the attached resolution.
