#### Call for a Permanent Exhibit Honoring Black Californians

Here in America, there continues to be a concentrated effort to erase and distort the true history of Black people. From Trump's executive orders targeting diversity, equity, and inclusion to the growing movement to censor and restrict educational content, the stories of Black struggle and achievement are being silenced. Federal and local institutions have removed or downplayed information about the long and ongoing fight for equality — effectively whitewashing the past.

This erasure should alarm all of us and inspire action.

Are you aware that the California State Museum in Sacramento does not have a permanent exhibit documenting and celebrating the history of Black Californians?

At a time when Black history is being challenged and erased from classrooms and cultural spaces through curriculum bans and book restrictions, preserving and sharing our stories is more important than ever. Truths once considered self-evident are being rewritten or erased before our eyes.

When your history is banned, how do you learn about your ancestors?

When your culture is erased, how do you see yourself?

How do we, as a people, understand our place in this state and this nation without knowing the full story of our contributions?


