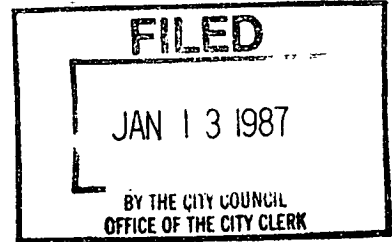


MEMORANDUM
