SUBJECT: APPROVAL OF AGREEMENT WITH THE GREATER SACRAMENTO AREA PLAN (GSAP)

LOCATION and COUNCIL DISTRICT

SUMMARY

This report recommends the adoption of the attached resolution, which authorizes the City Manager and City Clerk to execute an agreement with the Greater Sacramento Area Plan (GSAP) to provide support to Pre-Apprenticeship Programs and to develop and promote an Affirmative Action Program for contractors who are not signatory to a labor agreement.

STAFF RECOMMENDATION

It is recommended that the City Council adopt the attached resolution which authorizes the City Manager and City Clerk to execute an agreement with the Greater Sacramento Area Plan to provide support to Pre-Apprenticeship Programs and to develop and promote an Affirmative Action Program for contractors that are not signatory to a labor agreement.

BACKGROUND

Since 1974 the City has annually contracted with GSAP to provide field compliance and record keeping duties related to the affirmative action aspects of City construction contracts. Beginning in 1989 it was determined that GSAP would no longer be responsible for: reviewing bid specifications; attending pre-bid conferences; attending pre-construction conferences; conducting on-site compliance reviews; conducting on-site employee interviews; and preparing, compiling, and maintaining contract compliance reports and records. Instead, the GSAP would be charged with supporting Pre-Apprenticeship Programs to ensure the entry of qualified minorities and women into the construction work force and for developing and promoting an Affirmative Action Program for contractors who are not signatory to collective bargaining agreements.

Under this arrangement, the funding agencies (City, County, SHRA and the City of Davis) perform the field compliance and recording keeping functions and forward the information to the County for reporting to the U.S. Department of Labor (Office of Contract Compliance Programs). The GSAP organization provides construction contracting firms with technical assistance to ensure Affirmative Action and Equal Employment Opportunity on public works projects. In this fashion, we maintain our "Hometown Plan" status with the Department of Labor. Our "Hometown Plan" includes the seven county area of Sacramento, Yolo, Placer, Amador, El Dorado, Nevada and Sierra.

FINANCIAL CONSIDERATIONS

The 1991-1992 operating budget for GSAP is \$125,091. The Sacramento County portion is \$62,544, the City of Davis' portion is \$2,500, the SHRA portion is \$22,500 and the City's proposed agreement with GSAP is for \$37,547. This amount is available in the 91/92 FY operating budgets of the Engineering Division (\$26,282.90) and the Facility Management Division (\$11,264.10).

POLICY CONSIDERATIONS

City policy for a number of years has been to contract with the GSAP to achieve increased employment of minorities and women in the building and construction industry within the Sacramento-Sierra's Building and Construction Trades Council area and to provide for affirmative action functions necessary to increase the employment of women and minorities in the building and construction industry.
