SUBJECT: Agreement Between Southern Pacific Transportation Company

and the City of Sacramento for Construction of Sewer and Drain Lines as part of the Morrison Creek Drainage, Sewer

and Water Assessment District

SUMMARY:

Attached for Council approval is a copy of an agreement between Southern Pacific and the City of Sacramento concerning the crossing of railroad right-of-way by a proposed City storm drain and sanitary sewer.

BACKGROUND:

The Morrison Creek A/D project is located south and east of the Sacramento Army Signal Depot. Included in the assessment district project is the construction of storm drains and sanitary sewers. One of the storm drain lines as well as one of the sewer lines cross the railroad right-of-way at two different locations. The attached agreement will allow the contractor for the project to construct the pipe crossings across railroad property.

FINANCIAL:

According to the terms of the agreement, the City of Sacramento is to bear the cost of constructing and maintaining the pipe crossings. All construction costs will be charged to the assessment district.

RECOMMENDATION:

It is recommended that the City Council approve the agreement by adopting the attached resolution.
