WHEREAS, the Crocker Art Museum has received a gift from the estate of E. Kendell Davis; and

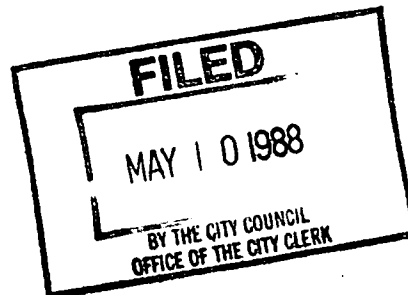
WHEREAS, this \$700,000 gift will provide the Museum with a substantial endowment for programs, exhibitions and related activities; and
