SUBJECT: Amendment to the Master Interagency Agreement

SUMMARY

The City is a party to the Sacramento Regional Wastewater Management Program - Master Interagency Agreement. The Sacramento Regional County Sanitation District is proposing an amendment to the Agreement to include six new areas into the district.

BACKGROUND

The City, various County Sanitation Districts, and the City of Folsom entered into the Master Interagency Agreement in November, 1974. At that time, specific boundaries were formed for the district. It is now being proposed to expand the boundaries of County Sanitation District #1 by the addition of six areas that require service. These six areas are all outside of the City limits. These areas are indicated in the attached amendment in Exhibit #J-1.

FINANCIAL

There will be no financial impact to the City as a result of this amendment.

RECOMMENDATION

It is recommended that the City Council approve the attached resolution authorizing the City Clerk and City Manager to execute the amendment to the Master Interagency Agreement as proposed.

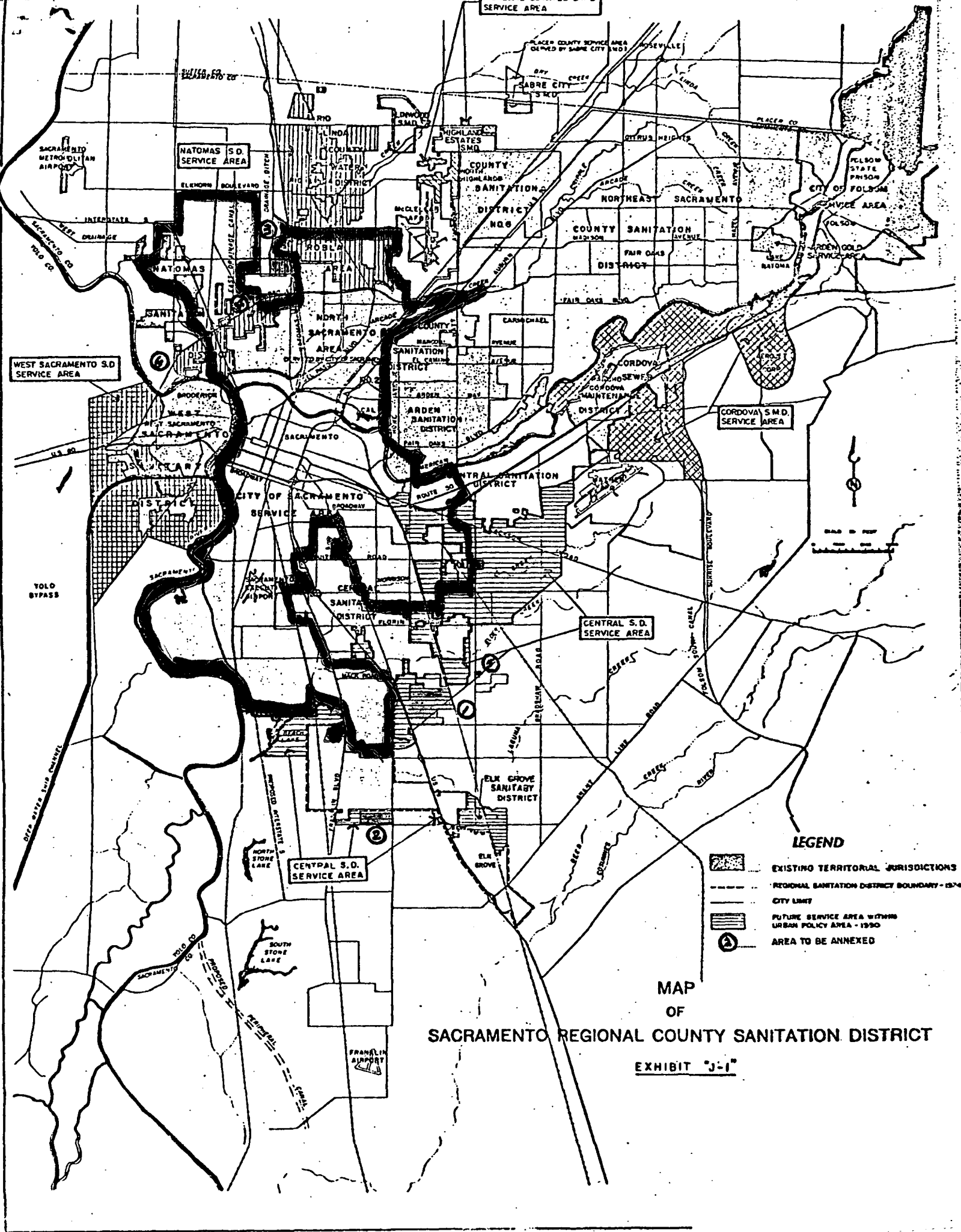
