SUBJECT: Extending Time on Contract for Improvement Proceed-

ing No. 4933, West Del Paso Heights Street Assessment

District No. 3

BACKGROUND INFORMATION

The Council awarded a contract to Teichert Construction on June 12th, 1979 for constructing concrete curbs, gutters and side-walks, asphaltic concrete pavement, storm sewers, drainage facilities, street lighting system complete and reconstruct water distribution system in the above named Assessment District. At the time of signing the contract, the completion date was scheduled for April 19th, 1980. Since that time one extension of time has been granted by the Council making the current completion date October 16th, 1980. However, a portion of the electrical work has not been completed and the quantities must be finalized and the assessment spread.

RECOMMENDATION

It is recommended therefore, that the Council grant an extension of 90 days to Teichert Construction by adoption of the attached Resolution Extending Time on Contract.
