SUBJECT: Amendment to Revocable Encroachment

SUMMARY

RESOLUTION AMENDING RESOLUTION NO. 80-157  
ADOPTED MARCH 18, 1980 RELATING TO REVOCABLE  
ENCROACHMENT PERMIT GRANTED TO KENNETH W. SIES

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

Resolution No. 80-157 adopted March 18, 1980 is hereby  
amended as follows:
