Recommendation: Adopt a **Resolution:** 1) Awarding a one year contract with two one year renewal options to Downtown Ford Sales, the lowest responsible and responsive bidder, for the purchase of various light duty trucks, vans and diagnostic equipment per Attachment 1 in an amount not to exceed \$2.8 million.

Description/Analysis:

Issue: The Department of General Services, Fleet Management Division, has a need to purchase various models of light trucks and vans, and the associated standard diagnostics tools for various departments within the City of Sacramento. In the past, Fleet Management has purchased these types of vehicles and equipment through cooperative purchasing agreements utilizing other government agency contracts such as the State of California, Department of General Services vehicle contracts.

Policy Considerations: The recommendations in this report are in accordance with the provisions of the City Code Section 3.56.

Committee/Commission Action: Not Applicable.

Environmental Considerations: The Environmental Services Manager has determined that the action of purchasing vehicles does not have the potential for

causing a significant effect on the environment and is therefore exempt under California Environmental Quality Act (CEQA) Guidelines, Categorical Exemption Section 15061(b)(3).

Fleet Management is committed to providing its customers with alternative fuel options wherever practical. Currently, alternative fueled vehicles available in the vehicle classes included in this bid do not share the same payload capacities as conventionally fueled trucks and vans. However, replacing vehicles averaging eight to ten years in service with current production vehicles significantly reduces the amount of exhausted emissions. All of the vehicles included in this contract are certified low emissions vehicles.

Rationale for Recommendation: As part of an ongoing organizational improvement effort, Fleet Management has been conducting competitive bidding for commodities and services wherever practicable rather than relying on cooperative agreements with other agencies. Fleet Management staff have worked with Procurement Services to solicit bids for known FY2006/07 vehicle purchasing requirements, as well as the forecasted requirements for FY2007/08 and FY2008/09.

This bid also included passenger minivans and full-sized sport utility vehicles. However, no award will be made for minivans, Schedule II of this bid, due to lack of participation for that schedule. Additionally, no award will be made for full-sized sport utility vehicles, Schedule XI. This schedule will be re-bid at a later date due to changes in the required specifications.

Financial Considerations: There are sufficient funds available in the Department of General Services, Fleet Management Division's FY2006/07 operating budget to purchase up to 55 vehicles (compact trucks, full-sized trucks, and full-sized vans) in an amount not to exceed \$981,290.

Additional purchases for the remaining quantities will be supported at the current bid price plus a maximum 5% annual escalation cost, and will be contingent upon FY2007/08 and FY 2008/09 budget appropriation for these types of vehicles.

Emerging Small Business Development (ESBD): Downtown Ford is not certified as an Emerging/Small Business Enterprise (ESBE). There are no known ESBE firms in this market.

AWARDING A ONE YEAR CONTRACT WITH TWO ONE YEAR RENEWAL OPTIONS TO DOWNTOWN FORD SALES FOR THE PURCHASE OF FORD VEHICLES AND DIAGNOSTIC TOOLS FOR AN AMOUNT NOT TO EXCEED \$2.8 MILLION

BACKGROUND

- A. The Department of General Services, Fleet Management Division, has ongoing customer requirements to purchase various models of light trucks and vans for various departments within the City of Sacramento.
- B. Fleet Management staff have worked with Procurement Services to solicit bids for the FY2006/07 requirements, as well as the forecasted requirements for FY2007/08 and FY2008/09.
- C. Downtown Ford Sales, 525 North 16th Street, Sacramento, CA is the lowest responsible and responsive bidder. This bid included passenger minivans and full-sized sport utility vehicles. However, no award will be made for minivans, Schedule II of this bid, due to lack of participation for that schedule. Additionally, no award will be made for full-sized sport utility vehicles, Schedule XI. This schedule will be re-bid at a later date due to changes in the required specifications.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. Award a one year contract with two one-year renewal options to Downtown Ford Sales, 525 North 16th Street, Sacramento, CA for the purchase of up to 69 compact pick-ups, 69 full-sized trucks, 10 full-sized vans and diagnostic tools in an amount not to exceed \$2.8 million.
- Section 2. Fleet Management staff is authorized to utilize these contracts to purchase up to 55 vehicles (compact pick-ups, full-sized trucks and full-sized vans) in an amount not to exceed \$981,290 in FY2006/07.
- Section 3. Fleet Management staff is authorized to utilize these contracts for additional purchases for the remaining quantities at the current bid price plus a maximum 5% annual escalation cost, and will be contingent upon FY 2007/08 and FY 2008/09 budget appropriation.

Section 4. Authorize the City Manager or his designee to issue the necessary purchase order and contract documents to procure equipment as described above.
